

## VOTES OF THE COMMITTEE

In compliance with the Rules of the House of Representatives, the following statement is made concerning the vote of the Committee on Ways and Means during the markup consideration of H.R. 6500, the “AGOA Extension Act” on December 10, 2025.

The vote on the amendment offered by Mr. Horsford to the amendment in the nature of a substitute to H.R. 6500, which prohibits the President from increasing tariffs on AGOA-eligible goods above their current statutory rates unless Congress approves the increase through a joint resolution of approval. Antidumping and countervailing duties, Section 232 national security tariffs, and Section 201 safeguard measures would be excluded from this prohibition. The amendment was not agreed to by a roll call vote of 17 yeas to 23 nays (with a quorum being present). The vote was as follows:
