## A BILL

To take certain Federal lands in Mono County, California, into trust for the benefit of the Bridgeport Indian Colony.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Bridgeport Indian Col-  
5 ony Land Trust, Health, and Economic Development Act  
6 of 2012”.

1 **SEC. 2. LANDS TO BE TAKEN INTO TRUST.**

2 (a) IN GENERAL.—Subject to valid existing rights  
3 and management agreements related to easements and  
4 rights-of-way, all right, title, and interest (including im-  
5 provements and appurtenances) of the United States in  
6 and to the Federal lands described in subsection (b) are  
7 hereby declared to be held in trust by the United States  
8 for the benefit of the Bridgeport Indian Colony, except  
9 that the oversight and renewal of all easements and rights-  
10 of-way with the Bridgeport Public Utility District in exist-  
11 ence on the date of the enactment of this Act shall remain  
12 the responsibility of the Bureau of Land Management.

13 (b) FEDERAL LANDS DESCRIBED.—The Federal  
14 lands referred to in subsection (a) are the approximately  
15 39.36 acres described as follows:

16 (1) The South half of the South half of the  
17 Northwest quarter of the Northwest quarter of the  
18 Northeast quarter and the North half of the South-  
19 west quarter of the Northwest quarter of the North-  
20 east quarter of Section 21, Township 8 North,  
21 Range 23 East, Mount Diablo Meridian, containing  
22 7.5 acres, more or less, as identified on the map ti-  
23 tled “Bridgeport Camp Antelope Parcel” and dated  
24 July 26, 2010.

25 (2) Lots 1 and 2 of the Bureau of Land Man-  
26 agement survey plat entitled “Dependent resurvey of

1 a portion of the subdivision of Section 28, designed  
2 to restore the corners in their true original locations  
3 according to the best available evidence, and the fur-  
4 ther subdivision of Section 28 and the metes and  
5 bounds survey of a portion of the right-of-way of  
6 California State Highway No. 182, Township 5  
7 North, Range 25 East, Mount Diablo Meridian,  
8 California” and dated February 21, 2003 containing  
9 31.86 acres, more or less.

10 (c) AVAILABILITY OF MAP.—The maps referred to in  
11 subsection (b) shall be on file and available for public in-  
12 spection at the office of the California State Director, Bu-  
13 reau of Land Management.

14 (d) GAMING.—Land taken into trust under this sec-  
15 tion shall not be eligible for, or considered to have been  
16 taken into trust for, class II gaming or class III gaming  
17 (as those terms are defined in section 4 of the Indian  
18 Gaming Regulatory Act (25 U.S.C. 2703)).
