

Suspend the Rules and Pass the Bill, H.R. 3527, with An Amendment

(The amendment strikes all after the enacting clause and inserts a new text)

To amend the Public Health Service Act to reauthorize the poison center national toll-free number, national media campaign, and grant program, and for other purposes.

A BILL

To amend the Public Health Service Act to reauthorize the poison center national toll-free number, national media campaign, and grant program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Poison Center Network
5 Act”.

1 **SEC. 2. REAUTHORIZATION OF POISON CONTROL CENTERS**
2 **NATIONAL TOLL-FREE NUMBER.**

3 Section 1271 of the Public Health Service Act (42
4 U.S.C. 300d–71) is amended by striking subsection (b)
5 and inserting the following:

6 “(b) AUTHORIZATION OF APPROPRIATIONS.—There
7 is authorized to be appropriated to carry out this section,
8 \$700,000 for each of fiscal years 2015 through 2019 for
9 the maintenance of the nationwide toll free phone number
10 under subsection (a).”.

11 **SEC. 3. REAUTHORIZATION OF NATIONWIDE MEDIA CAM-**
12 **PAIGN TO PROMOTE POISON CONTROL CEN-**
13 **TER UTILIZATION.**

14 Section 1272 of the Public Health Service Act (42
15 U.S.C. 300d–72) is amended—

16 (1) in subsection (c)(2), by striking the comma
17 after “Congress”; and

18 (2) by striking subsection (d) and inserting the
19 following:

20 “(d) AUTHORIZATION OF APPROPRIATIONS.—There
21 is authorized to be appropriated to carry out this section,
22 \$800,000 for each of fiscal years 2015 through 2019.”.

23 **SEC. 4. REAUTHORIZATION OF THE POISON CONTROL CEN-**
24 **TER GRANT PROGRAM.**

25 (a) IN GENERAL.—Section 1273 of the Public Health
26 Service Act (42 U.S.C. 300d–73) is amended—

1 (1) in subsection (a)—

2 (A) by striking “certified” and inserting
3 “accredited”; and

4 (B) by striking “certification” and insert-
5 ing “accreditation”;

6 (2) in subsection (b)—

7 (A) in paragraph (1), by striking “estab-
8 lish” and inserting “research, establish, imple-
9 ment,”;

10 (B) by redesignating paragraphs (4)
11 through (7) as paragraphs (5) through (8);

12 (C) by inserting after paragraph (3), the
13 following:

14 “(4) to research, improve, and enhance the
15 communications and response capability and capac-
16 ity of the nation’s network of poison control centers
17 to facilitate increased access to the Centers through
18 the integration and modernization of the current
19 poison control centers communications and data sys-
20 tem, including enhancing the network’s telephony,
21 Internet, data and social networking technologies;”;

22 (D) in paragraph (6) (as so redesignated),
23 by striking “paragraph (4)” and inserting
24 “paragraph (5)”; and

1 (E) in paragraph (8) (as so redesignated),
2 by striking “and respond” and inserting “and
3 Internet communications, and to sustain and
4 enhance the poison control center’s network ca-
5 pability to respond”;

6 (3) in subsection (c)—

7 (A) in the subsection heading, by striking
8 “CERTIFICATION” and inserting “ACCREDITA-
9 TION”;

10 (B) by striking “certified” each place that
11 such term appears and inserting “accredited”;
12 and

13 (C) by striking “certification” each place
14 that such term appears and inserting “accredi-
15 tation”;

16 (4) in subsection (d)—

17 (A) in the subsection heading, by striking
18 “CERTIFICATION” and inserting “ACCREDITA-
19 TION”;

20 (B) in paragraph (1)—

21 (i) by striking “the certification” and
22 inserting “the accreditation”;

23 (ii) by striking “a noncertified” and
24 inserting “a nonaccredited”; and

1 (iii) by striking “a certification” and
2 inserting “an accreditation”; and

3 (C) in paragraph (3)—

4 (i) by striking the last sentence; and

5 (ii) by striking “exceed 5 years.” and
6 inserting the following “exceed—

7 “(A) 5 years; or

8 “(B) in the case of a nonaccredited poison
9 control center operating pursuant to a waiver
10 under this subsection as of October 1, 2014, 6
11 years.”;

12 (5) in subsection (f), by striking “for activities
13 of the center” and inserting “for its activities”; and

14 (6) by striking subsection (g) and inserting the
15 following:

16 “(g) AUTHORIZATION OF APPROPRIATIONS.—There
17 is authorized to be appropriated to carry out this section,
18 \$28,600,000 for each of fiscal years 2015 through 2019.
19 The Secretary may utilize an amount not to exceed 6 per-
20 cent of the amount appropriated under this preceding sen-
21 tence in each fiscal year for coordination, dissemination,
22 technical assistance, program evaluation, data activities,
23 and other program administration functions, which are de-
24 termined by the Secretary to be appropriate for carrying
25 out the program under this section.”.

1 (b) EFFECTIVE DATE.—The amendments made by
2 subsection (a) shall take effect on the date of the enact-
3 ment of this Act and shall apply to grants made on or
4 after October 1, 2014.
