A BILL

To direct the Commandant of the Coast Guard to convey certain property from the United States to the City of Baudette, Minnesota.

1 (d) *COSTS OF CONVEYANCE.*—*The responsibility for all*
2 *reasonable and necessary costs, including real estate trans-*
3 *action and environmental documentation costs, associated*
4 *with a conveyance under this section shall be determined*
5 *by the Commandant and the city of Baudette, Minnesota.*

6 (e) *ADDITIONAL TERMS AND CONDITIONS.*—*The Com-*
7 *mandant may require such additional terms and conditions*
8 *in connection with a conveyance under this section as the*
9 *Commandant considers appropriate and reasonable to pro-*
10 *tect the interests of the United States.*

11 (f) *DEPOSIT OF PROCEEDS.*—*Any proceeds received by*
12 *the United States from a conveyance under this section shall*
13 *be deposited in the Coast Guard Housing Fund established*
14 *under section 687 of title 14, United States Code.*

15 (g) *CONDITION ON USE.*—*As a condition of any con-*
16 *veyance under this section, the Commandant shall require*
17 *that all right, title, and interest in and to the covered prop-*
18 *erty shall revert to the United States if the covered property*
19 *or any part thereof ceases to be used for—*

20 (1) *affordable housing or a purpose related to af-*
21 *fordable housing (as defined by the city of Baudette,*
22 *Minnesota, and the Commandant at the time of con-*
23 *veyance); or*

24 (2) *infrastructure that provides a public benefit*
25 *approved by the city of Baudette, Minnesota.*

1 (h) *COVERED PROPERTY DEFINED.*—*In this section,*
2 *the term “covered property” means the Federal lands (in-*
3 *cluding all buildings, structures, utilities, and miscella-*
4 *neous facilities on the lands) that are under the administra-*
5 *tive control of the Coast Guard and located at the following*
6 *addresses:*

7 (1) *416 Hamilton E #7 Baudette, MN 56623.*

8 (2) *414 Hamilton E #6 Baudette, MN 56623.*

9 (3) *412 Hamilton E #5 Baudette, MN 56623.*

10 (4) *410 Hamilton E #4 Baudette, MN 56623.*

11 (i) *EXPIRATION.*—*The authority to convey the covered*
12 *property under this section shall expire on the date that*
13 *is 4 years after the date of enactment of this Act.*

14 (j) *RULE OF CONSTRUCTION.*—*Nothing in this section*
15 *may be construed to affect or limit the application of or*
16 *obligation to comply with any Federal environmental re-*
17 *quirement, including section 120(h) of the Comprehensive*
18 *Environmental Response, Compensation, and Liability Act*
19 *of 1980 (42 U.S.C. 9620(h)).*
