# **A BILL**

To ensure the effective processing of mail by Federal agencies, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Federal Agency Mail  
5 Management Act of 2016”.

6 **SEC. 2. RECORD MANAGEMENT.**

7       (a) AMENDMENTS.—Section 9 of the Presidential and  
8 Federal Records Act Amendments of 2014 (44 U.S.C. 101  
9 note) is amended—

10           (1) in subsection (a), by amending paragraph

11           (3) to read as follows:

12           “(3) in paragraph (7), by striking ‘the Adminis-  
13 trator or the Archivist’ and inserting ‘the Archivist  
14 or the Administrator.’.”;

15           (2) in subsection (c)—

16           (A) by amending paragraph (1) to read as  
17 follows:

18           “(1) by amending subsection (a) to read as fol-  
19 lows:

20           “(a) The Archivist shall provide guidance and assist-  
21 ance to Federal agencies with respect to ensuring—

22           “(1) economical and effective records manage-  
23 ment;

1           “(2) adequate and proper documentation of  
2           the policies and transactions of the Federal Govern-  
3           ment; and

4           “(3) proper records disposition.’;

5           (B) by redesignating paragraphs (2) and  
6           (3) as paragraphs (3) and (4), respectively;

7           (C) by inserting after paragraph (1), the  
8           following new paragraph:

9           “(2) in subsection (b), by striking ‘effective  
10          records management by such agencies’ and inserting  
11          ‘effective processing of mail by Federal agencies’;”;

12          (D) in paragraph (3), as so redesignated—

13                 (i) in subparagraph (A)(ii), by strik-  
14                 ing “‘subsections (a) and (b)’” and insert-  
15                 ing “‘subsection (a)’”; and

16                 (ii) in subparagraph (B), by striking  
17                 “; and” and inserting a semicolon;

18          (E) in paragraph (4), as so redesignated,  
19          by striking the period at the end and inserting  
20          “; and”; and

21          (F) by inserting at the end the following  
22          new paragraph:

23          “(5) by inserting at the end the following new  
24          subsection:

1           “(e) The Administrator, in carrying out subsection  
2 (b), shall have the responsibility to promote economy and  
3 efficiency in the selection and utilization of space, staff,  
4 equipment, and supplies for processing mail at Federal fa-  
5 cilities.’.

6           (3) in subsection (d)—

7                 (A) in paragraph (1), by striking “; and”  
8 at the end and inserting a semicolon;

9                 (B) in paragraph (2), by striking the pe-  
10 riod at the end and inserting “; and”; and

11                 (C) by inserting at the end the following  
12 new paragraph:

13                 “(3) by inserting at the end the following new  
14 subsection:

15           “(e) The Administrator (or the Administrator’s des-  
16 ignee) may inspect the mail processing practices and pro-  
17 grams of any Federal agency for the purpose of rendering  
18 recommendations for the improvement of mail processing  
19 practices and programs. Officers and employees of such  
20 agencies shall cooperate fully in such inspections of mail  
21 processing practices and programs.’.

22           (4) by striking subsection (f); and

23           (5) by redesignating subsection (g) as sub-  
24 section (f).

1           (b) EFFECTIVE DATE.—The amendments made by  
2 this section shall take effect as if included in the Presi-  
3 dential and Federal Records Act Amendments of 2014  
4 (Public Law 113–187).
