**A BILL**

To reauthorize the United States Fire Administration, the Assistance to Firefighters Grants program, the Fire Prevention and Safety Grants program, and the Staffing for Adequate Fire and Emergency Response grant program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States Fire  
5 Administration, AFG, and SAFER Program Reauthoriza-  
6 tion Act of 2017”.

1 **SEC. 2. REAUTHORIZATION OF THE UNITED STATES FIRE**  
2 **ADMINISTRATION.**

3 Section 17(g)(1)(M) of the Federal Fire Prevention  
4 and Control Act of 1974 (15 U.S.C. 2216 (g)(1)(M)) is  
5 amended—

6 (1) by striking “fiscal year 2017” and inserting  
7 “for each of fiscal years 2017 through 2023”; and

8 (2) by inserting “for each such fiscal year”  
9 after “\$2,753,672”.

10 **SEC. 3. REAUTHORIZATION OF ASSISTANCE TO FIRE-**  
11 **FIGHTERS GRANTS PROGRAM AND THE FIRE**  
12 **PREVENTION AND SAFETY GRANTS PRO-**  
13 **GRAM.**

14 (a) SUNSET.—Section 33(r) of the Federal Fire Pre-  
15 vention and Control Act of 1974 (15 U.S.C. 2229(r)) is  
16 amended by striking “the date that is 5 years after the  
17 date of the enactment of the Fire Grants Reauthorization  
18 Act of 2012” and inserting “September 30, 2024”.

19 (b) AUTHORIZATION OF APPROPRIATIONS.—Section  
20 33(q)(1)(B) of the Federal Fire Prevention and Control  
21 Act of 1974 (15 U.S.C. 2229(q)(1)(B)) is amended, in the  
22 matter preceding clause (i), by striking “2017” and insert-  
23 ing “2023”.

24 (c) AUTHORIZATION FOR CERTAIN TRAINING UNDER  
25 ASSISTANCE TO FIREFIGHTERS GRANTS PROGRAM.—Sec-  
26 tion 33(c)(3) of the Federal Fire Prevention and Control

1 Act of 1974 (15 U.S.C. 2229(c)(3)) is amended by adding  
2 at the end the following:

3 “(N) To provide specialized training to  
4 firefighters, paramedics, emergency medical  
5 service workers, and other first responders to  
6 recognize individuals who have mental illness  
7 and how to properly intervene with individuals  
8 with mental illness, including strategies for  
9 verbal de-escalation of crisis.”.

10 **SEC. 4. REAUTHORIZATION OF STAFFING FOR ADEQUATE**  
11 **FIRE AND EMERGENCY RESPONSE GRANT**  
12 **PROGRAM.**

13 (a) SUNSET.—Section 34(k) of the Federal Fire Pre-  
14 vention and Control Act of 1974 (15 U.S.C. 2229a(k))  
15 is amended by striking “the date that is 5 years after the  
16 date of the enactment of the Fire Grants Reauthorization  
17 Act of 2012” and inserting “September 30, 2024”.

18 (b) AUTHORIZATION OF APPROPRIATIONS.—Section  
19 34(j)(1)(I) of the Federal Fire Prevention and Control Act  
20 of 1974 (15 U.S.C. 2229a(j)(1)(I)) is amended, in the  
21 matter preceding clause (i), by striking “2017” and insert-  
22 ing “2023”.

23 (c) MODIFICATION OF APPLICATION REQUIRE-  
24 MENTS.—Section 34(b)(3)(B) of the Federal Fire Preven-  
25 tion and Control Act of 1974 (15 U.S.C. 2229a(b)(3)(B))

1 is amended by striking “of subsection (a)(1)(B)(ii) and  
2 (F)” and inserting “of subsection (a)(1)(F)”.

3 (d) MODIFICATION OF LIMITATION.—Section  
4 34(c)(2) of the Federal Fire Prevention and Control Act  
5 of 1974 (15 U.S.C. 2229a(c)(2)) is amended by striking  
6 “prior to the date of enactment of this section” and insert-  
7 ing “prior to the date of the application for the grant”.

8 (e) MODIFICATION OF WAIVER AUTHORITY.—Section  
9 34(d)(1)(B) of the Federal Fire Prevention and Control  
10 Act of 1974 (15 U.S.C. 2229a(d)(1)(B)) is amended by  
11 striking “subsection (a)(1)(E) or subsection (c)(2)” and  
12 inserting “subsection (a)(1)(E), (c)(2), or (c)(4)”.

13 (f) EXPANSION OF STAFFING FOR ADEQUATE FIRE  
14 AND EMERGENCY RESPONSE GRANT PROGRAM; REPEAL  
15 OF AUTHORITY FOR CERTAIN USE OF GRANT AMOUNTS  
16 TRANSFERRED TO ASSISTANCE TO FIREFIGHTERS  
17 GRANTS PROGRAM.—Section 34(a)(1)(B) of the Federal  
18 Fire Prevention and Control Act of 1974 (15 U.S.C.  
19 2229a(a)(1)(B)) is amended—

20 (1) by inserting “or to change the status of  
21 part-time or paid-on-call (as defined in section  
22 33(a)) firefighters to full-time firefighters” after  
23 “firefighters”; and

24 (2) by striking “and to provide” and all that  
25 follows through “of crises”.

1 **SEC. 5. TRAINING ON ADMINISTRATION OF FIRE GRANT**  
2 **PROGRAMS.**

3 (a) **IN GENERAL.**—The Administrator of the Federal  
4 Emergency Management Agency, acting through the Ad-  
5 ministrator of the United States Fire Administration, may  
6 develop and make widely available an electronic, online  
7 training course for members of the fire and emergency re-  
8 sponse community on matters relating to the administra-  
9 tion of grants under sections 33 and 34 of the Federal  
10 Fire Prevention and Control Act of 1974 (15 U.S.C. 2229  
11 and 2229a).

12 (b) **REQUIREMENTS.**—The Administrator of the Fed-  
13 eral Emergency Management Agency shall ensure that  
14 any training developed and made available under sub-  
15 section (a) is—

16 (1) tailored to the financial and time con-  
17 straints of members of the fire and emergency re-  
18 sponse community; and

19 (2) accessible to all individuals in the career,  
20 combination, paid-on-call, and volunteer fire and  
21 emergency response community.

1 **SEC. 6. FRAMEWORK FOR OVERSIGHT AND MONITORING**  
2 **OF THE ASSISTANCE TO FIREFIGHTERS**  
3 **GRANTS PROGRAM, THE FIRE PREVENTION**  
4 **AND SAFETY GRANTS PROGRAM, AND THE**  
5 **STAFFING FOR ADEQUATE FIRE AND EMER-**  
6 **GENCY RESPONSE GRANT PROGRAM.**

7 (a) FRAMEWORK.—Not later than 90 days after the  
8 date of enactment of this Act, the Administrator of the  
9 Federal Emergency Management Agency, acting through  
10 the Administrator of the United States Fire Administra-  
11 tion, shall develop and implement a grant monitoring and  
12 oversight framework to mitigate and minimize risks of  
13 fraud, waste, abuse, and mismanagement relating to the  
14 grants programs under sections 33 and 34 of the Federal  
15 Fire Prevention and Control Act of 1974 (15 U.S.C. 2229  
16 and 2229a).

17 (b) ELEMENTS.—The framework required under sub-  
18 section (a) shall include the following:

19 (1) Developing standardized guidance and  
20 training for all participants in the grant programs  
21 described in subsection (a).

22 (2) Conducting regular risk assessments.

23 (3) Conducting desk reviews and site visits.

24 (4) Enforcement actions to recoup potential  
25 questionable costs of grant recipients.

1           (5) Such other oversight and monitoring tools  
2           as the Administrator of the Federal Emergency  
3           Management Agency considers necessary to mitigate  
4           and minimize fraud, waste, abuse, and mismanage-  
5           ment relating to the grant programs described in  
6           subsection (a).
