A BILL

To revise the authorized route of the North Country National Scenic Trail in northeastern Minnesota and to extend the trail into Vermont to connect with the Appalachian National Scenic Trail, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “North Country National*
5 *Scenic Trail Route Adjustment Act”.*

6 **SEC. 2. ROUTE ADJUSTMENT.**

7 *Section 5(a)(8) of the National Trails System Act (16*
8 *U.S.C. 1244(a)(8)) is amended in the first sentence—*

9 *(1) by striking “thirty-two hundred miles, ex-*
10 *tending from eastern New York State” and inserting*
11 *“4,600 miles, extending from the Appalachian Trail*
12 *in Vermont”; and*

13 *(2) by striking “Proposed North Country Trail”*
14 *and all that follows through “June 1975.” and insert-*
15 *ing “‘North Country National Scenic Trail, Author-*
16 *ized Route’, dated February 2014, and numbered 649/*
17 *116870.”.*

18 **SEC. 3. LAND ACQUISITION.**

19 *Neither the Secretary of Agriculture nor the Secretary*
20 *of the Interior may acquire for the North Country National*
21 *Scenic Trail land in Minnesota or Vermont that was ob-*
22 *tained through condemnation by a State or local govern-*
23 *ment.*

1 **SEC. 4. ENERGY.**

2 *Nothing in the amendments made by this Act that*
3 *change the authorized route of the North Country National*
4 *Scenic Trail in Minnesota or Vermont shall prohibit the*
5 *development, production, conveyance, or transmission of en-*
6 *ergy in those States, with reasonable efforts made to pre-*
7 *serve the nature and purpose of the North Country National*
8 *Scenic Trail, and to mitigate any damage to that trail and*
9 *its associated resources caused by such activities.*
