# **A BILL**

To authorize the National Emergency Medical Services Memorial Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORIZATION TO ESTABLISH COMMEMORA-**  
4 **TIVE WORK.**

5        (a) *IN GENERAL.—The National Emergency Medical*  
6 *Services Memorial Foundation may establish a commemo-*  
7 *rative work on Federal land in the District of Columbia*  
8 *and its environs to commemorate the commitment and serv-*  
9 *ice represented by emergency medical services.*

10        (b) *COMPLIANCE WITH STANDARDS FOR COMMEMORA-*  
11 *TIVE WORKS.—The establishment of the commemorative*  
12 *work under this section shall be in accordance with chapter*  
13 *89 of title 40, United States Code (commonly known as the*  
14 *“Commemorative Works Act”).*

15        (c) *PROHIBITION ON THE USE OF FEDERAL FUNDS.—*

16            (1) *IN GENERAL.—Federal funds may not be*  
17 *used to pay any expense of the establishment of the*  
18 *commemorative work under this section.*

19            (2) *RESPONSIBILITY OF NATIONAL EMERGENCY*  
20 *MEDICAL SERVICES MEMORIAL FOUNDATION.—The*  
21 *National Emergency Medical Services Memorial*  
22 *Foundation shall be solely responsible for acceptance*  
23 *of contributions for, and payment of the expenses of,*  
24 *the establishment of the commemorative work under*  
25 *this section.*

1       (d) *DEPOSIT OF EXCESS FUNDS.*—

2               (1) *IN GENERAL.*—If upon payment of all ex-  
3       penses for the establishment of the memorial (includ-  
4       ing the maintenance and preservation amount re-  
5       quired by section 8906(b)(1) of title 40, United States  
6       Code), there remains a balance of funds received for  
7       the establishment of the commemorative work, the  
8       Foundation shall transmit the amount of the balance  
9       to the Secretary of the Interior for deposit in the ac-  
10      count provided for in section 8906(b)(3) of title 40,  
11      United States Code.

12              (2) *ON EXPIRATION OF AUTHORITY.*—If upon ex-  
13      piration of the authority for the commemorative work  
14      under section 8903(e) of title 40, United States Code,  
15      there remains a balance of funds received for the es-  
16      tablishment of the commemorative work, the Founda-  
17      tion shall transmit the amount of the balance to a  
18      separate account with the National Park Foundation  
19      for memorials, to be available to the Secretary of the  
20      Interior or Administrator (as appropriate) following  
21      the process provided in section 8906(b)(4) of title 40,  
22      United States Code, for accounts established under  
23      8906(b)(2) or (3) of title 40, United States Code.
