# A BILL

To direct the Secretary of Agriculture to convey certain National Forest System land containing the Nephi Work Center in Juab County, Utah, to Juab County.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Juab County Convey-*  
5   *ance Act of 2018”.*

6   **SEC. 2. LAND CONVEYANCE, NEPHI WORK CENTER, JUAB**

7                   **COUNTY, UTAH.**

8       (a) *CONVEYANCE REQUIRED.—Subject to valid exist-*  
9   *ing rights, if the County submits a written request to the*  
10   *Secretary not later than 90 days after the date of enactment*  
11   *of this Act, the Secretary shall convey, without consider-*  
12   *ation and by quitclaim deed, to the County all right, title,*  
13   *and interest of the United States in and to the parcel of*  
14   *National Forest System land, including improvements*  
15   *thereon, described in subsection (b).*

16       (b) *DESCRIPTION OF LAND.—*

17               (1) *IN GENERAL.—The parcel of National Forest*  
18   *System land and improvements to be conveyed under*  
19   *subsection (a) is the Nephi Work Center at 740 South*  
20   *Main Street, Nephi, Utah, which consists of approxi-*  
21   *mately 2.17 acres within Nephi Plat B Block of the*  
22   *Nephi Townsite Survey as Parcels #XA00-0545-1111*  
23   *and #XA00-0545-2, and is identified on the map en-*  
24   *titled “Nephi Plat B” and dated May 6, 1981.*

25               (2) *MAP AND LEGAL DESCRIPTION.—*

1                             (A) *IN GENERAL.*—As soon as practical  
2                             *after the date of enactment of this Act, the Sec-*  
3                             *retary shall submit to the Committee on Natural*  
4                             *Resources of the House of Representatives and*  
5                             *the Committee on Agriculture, Nutrition, and*  
6                             *Forestry of the Senate a map and legal descrip-*  
7                             *tion of the parcel described in paragraph (1).*

8                             (B) *MINOR MODIFICATIONS.*—The map and  
9                             *legal description submitted under this paragraph*  
10                             *shall have the same force and effect as if included*  
11                             *in this Act, except that the Secretary may make*  
12                             *minor modifications of any clerical or typo-*  
13                             *graphical errors in the map or the legal descrip-*  
14                             *tion.*

15                             (C) *COPY ON FILE.*—A copy of the map and  
16                             *the legal description shall be on file and avail-*  
17                             *able for public inspection in the appropriate*  
18                             *field offices of the U.S. Forest Service.*

19                             (c) *SURVEY.*—The exact acreage and legal description  
20                             *of the National Forest System land to be conveyed under*  
21                             *subsection (a) shall be determined by a survey satisfactory*  
22                             *to the Secretary.*

23                             (d) *COSTS OF CONVEYANCE.*—As a condition for the  
24                             *conveyance under subsection (a), the County shall pay the*  
25                             *reasonable costs incurred by the Secretary for—*

1                   (1) the survey required by subsection (c); and  
2                   (2) any environmental or administrative anal-  
3                   ysis required by law related to the conveyance.

4                   (e) ADDITIONAL TERMS AND CONDITIONS.—The con-  
5                   veyance under subsection (a) is subject to any other terms  
6                   and conditions as the Secretary considers appropriate to  
7                   protect the interests of the United States.

8                   (f) TIME FOR COMPLETION OF CONVEYANCE.—The  
9                   Secretary shall complete the conveyance under subsection  
10                  (a) not later than one year after the date on which the  
11                  County submits the written request described in subsection  
12                  (a).

13                  (g) DEFINITIONS.—In this Act:

14                  (1) COUNTY.—The term “County” means Juab  
15                  County, Utah.

16                  (2) SECRETARY.—The term “Secretary” means  
17                  the Secretary of Agriculture, acting through the Chief  
18                  of the U.S. Forest Service.
