A BILL

To establish the Adams Memorial Commission to carry out the provisions of Public Law 107–62, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ADAMS MEMORIAL COMMISSION.**

4 (a) *COMMISSION.*—*There is established a commission*
5 *to be known as the “Adams Memorial Commission” (re-*
6 *ferred to in this section as the “Commission”) for the pur-*
7 *pose of establishing a permanent memorial to honor John*
8 *Adams and his legacy as authorized by Public Law 107–*
9 *62, located in the city of Washington, District of Columbia,*
10 *including sites authorized by Public Law 107–315.*

11 (b) *MEMBERSHIP.*—*The Commission shall be com-*
12 *posed of—*

13 (1) *four persons appointed by the President, not*
14 *more than two of whom may be members of the same*
15 *political party;*

16 (2) *four Members of the Senate appointed by the*
17 *President pro tempore of the Senate in consultation*
18 *with the Majority Leader and Minority Leader of the*
19 *Senate, of which not more than two appointees may*
20 *be members of the same political party; and*

21 (3) *four Members of the House of Representatives*
22 *appointed by the Speaker of the House of Representa-*
23 *tives in consultation with the Majority Leader and*
24 *Minority Leader of the House of Representatives, of*

1 *which not more than two appointees may be members*
2 *of the same political party.*

3 (c) *CHAIR AND VICE CHAIR.*—*The members of the*
4 *Commission shall select a Chair and Vice Chair of the Com-*
5 *mission. The Chair and Vice Chair shall not be members*
6 *of the same political party.*

7 (d) *VACANCIES.*—*Any vacancy in the Commission*
8 *shall not affect its powers if a quorum is present, but shall*
9 *be filled in the same manner as the original appointment.*

10 (e) *MEETINGS.*—

11 (1) *INITIAL MEETING.*—*Not later than 45 days*
12 *after the date on which a majority of the members of*
13 *the Commission have been appointed, the Commission*
14 *shall hold its first meeting.*

15 (2) *SUBSEQUENT MEETINGS.*—*The Commission*
16 *shall meet at the call of the Chair.*

17 (f) *QUORUM.*—*A majority of the members of the Com-*
18 *mission shall constitute a quorum but a lesser number of*
19 *members may hold hearings.*

20 (g) *NO COMPENSATION.*—*A member of the Commission*
21 *shall serve without compensation, but may be reimbursed*
22 *for expenses incurred in carrying out the duties of the Com-*
23 *mission.*

24 (h) *DUTIES.*—*The Commission shall consider and for-*
25 *mulate plans for a permanent memorial to honor John*

1 *Adams and his legacy, including the nature, location, de-*
2 *sign, and construction of the memorial.*

3 (i) *POWERS.—The Commission may—*

4 (1) *make such expenditures for services and ma-*
5 *terials for the purpose of carrying out this section as*
6 *the Commission considers advisable from funds ap-*
7 *propriated or received as gifts for that purpose;*

8 (2) *accept gifts, including funds from the Adams*
9 *Memorial Foundation, to be used in carrying out this*
10 *section or to be used in connection with the construc-*
11 *tion or other expenses of the memorial; and*

12 (3) *hold hearings, enter into contracts for per-*
13 *sonal services and otherwise, and do such other things*
14 *as are necessary to carry out this section.*

15 (j) *REPORTS.—The Commission shall—*

16 (1) *report the plans required by subsection (h),*
17 *together with recommendations, to the President and*
18 *the Congress at the earliest practicable date; and*

19 (2) *in the interim, make annual reports on its*
20 *progress to the President and the Congress.*

21 (k) *APPLICABILITY OF OTHER LAWS.—The Federal*
22 *Advisory Committee Act (5 U.S.C. App.) shall not apply*
23 *to the Commission.*

24 (l) *TERMINATION.—The Commission shall terminate 7*
25 *years after the date of the enactment of this Act.*

1 **SEC. 2. AMENDMENT TO PUBLIC LAW 107-62.**

2 *Public Law 107-62 is amended by striking “Adams*
3 *Memorial Foundation” each place it occurs and inserting*
4 *“Adams Memorial Commission”.*
