To amend the Homeland Security Act of 2002 to establish in the Department of Homeland Security an Unmanned Aircraft Systems Coordinator, and for other purposes.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "DHS Countering Un-

2	MEASURES COORDINATOR.
3	(a) In General.—Title III of the Homeland Secu-
4	rity Act of 2002 (6 U.S.C. 181 et seq.) is amended by

6	"SEC. 321. COUNTERING UNMANNED AIRCRAFT SYSTEMS
7	COORDINATOR.
8	"(a) COORDINATOR.—The Secretary shall designate
9	an official of the Department as the Countering Un-
10	manned Aircraft Systems (UAS) Coordinator (in this sec-
11	tion referred to as the 'Coordinator') to coordinate with
12	relevant Department offices and components on the devel-
13	opment of policies and plans to counter threats associated
14	with UAS, including—
15	"(1) countering UAS that may be used in a ter-
16	rorist attack;
17	"(2) promoting research and development of
18	counter UAS technologies;
19	"(3) ensuring the dissemination of information
20	and guidance related to countering UAS threats;
21	"(4) serving as the Department point of contact
22	for Federal, State, local, and tribal law enforcement
23	entities and the private sector regarding the Depart-
24	ment's activities related to countering UAS; and
25	"(5) carrying out other related UAS activities,
26	as directed by the Secretary.

1	"(b) Coordination With Applicable Federal
2	Laws.—The Coordinator shall, in addition to other as-
3	signed duties, coordinate with relevant Department com-
4	ponents and offices to ensure testing, evaluation, or de-
5	ployment of a system used to identify, assess, or defeat
6	a UAS is carried out in accordance with applicable Fed-
7	eral laws.
8	"(c) Coordination With Private Sector.—The
9	Coordinator shall, working with the Office of Partnership
10	and Engagement and other relevant Department offices
11	and components, or other Federal agencies, as appro-
12	priate, serve as the principal Department official respon-
13	sible for disseminating to the private sector information
14	regarding counter UAS technology, particularly informa-
15	tion regarding instances in which counter UAS technology
16	may impact lawful private sector services or systems.".
