

Suspend the Rules and Pass the Bill, H.R. 5787, With an Amendment

(The amendment strikes all after the enacting clause and inserts a new text)

To amend the Coastal Barrier Resources Act to give effect to more accurate maps of units of the John H. Chafee Coastal Barrier Resources System that were produced by digital mapping of such units, and for other purposes.

Mr. DUNN (for himself, Ms. BLUNT ROCHESTER, and Mr. THOMAS J. ROONEY of Florida) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To amend the Coastal Barrier Resources Act to give effect to more accurate maps of units of the John H. Chafee Coastal Barrier Resources System that were produced by digital mapping of such units, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Strengthening Coastal
5 Communities Act of 2018”.

1 **SEC. 2. REPLACEMENT OF JOHN H. CHAFEE COASTAL BAR-**
2 **RIER RESOURCES SYSTEM MAPS.**

3 (a) IN GENERAL.—Subject to subsection (c), each
4 map included in the set of maps referred to in section 4(a)
5 of the Coastal Barrier Resources Act (16 U.S.C. 3503(a))
6 that relates to a Unit of such System referred to in sub-
7 section (b) of this section is replaced in such set with the
8 map described in subsection (b) with respect to that Unit.

9 (b) REPLACEMENT MAPS DESCRIBED.—The replace-
10 ment maps referred to in subsection (a) are the following:

7 (c) LIMITATIONS.—For purposes of subsection (a)—

8 (1) nothing in this section affects the bound-
9 aries of any of Units NC-06 and NC-06P;

10 (2) the occurrence in subsection (b) of the name
11 of a Unit solely in the title of a map shall not be
12 construed to be a reference to such Unit; and

13 (3) the depiction of boundaries of any of Units
14 P18P, FL-71P, and P24P in a map referred to in
15 paragraph (22), (24), or (27) of subsection (b) shall
16 not be construed to affect the boundaries of such
17 Unit.

18 (d) CONFORMING AMENDMENT.—Section 4(a) of the
19 Coastal Barrier Resources Act (16 U.S.C. 3503(a)) is
20 amended—

21 (1) in the matter preceding paragraph (1), by
22 inserting “replaced,” after “may be”; and

23 (2) in paragraph (3), by inserting “replaces
24 such a map or” after “that specifically”.

1 **SEC. 3. DIGITAL MAPS OF JOHN H. CHAFEE COASTAL BAR-**
2 **RIER RESOURCES SYSTEM UNITS.**

3 Section 4(b) of the Coastal Barrier Resources Act (16
4 U.S.C. 3503(b)) is amended—

5 (1) by inserting before the first sentence the
6 following:

7 “(1) IN GENERAL.—”; and

8 (2) by adding at the end the following:

9 “(2) DIGITAL MAPS.—

10 “(A) AVAILABILITY.—The Secretary shall
11 make available to the public on the Internet
12 web site of the United States Fish and Wildlife
13 Service digital versions of the maps included in
14 the set of maps referred to in subsection (a).

15 “(B) EFFECT.—Any determination as to
16 whether a location is inside or outside the Sys-
17 tem shall be made without regard to the digital
18 maps available under this paragraph, except
19 that this subparagraph does not apply with re-
20 spect to any printed version of such a digital
21 map if the printed version is included in the
22 maps referred to in subsection (a).

23 “(C) REPORT.—No later than 180 days
24 after the date of the enactment of the Strength-
25 ening Coastal Communities Act of 2018, the
26 Secretary shall submit to the Committee on

1 Natural Resources of the House of Representa-
2 tives and the Committee on Environment and
3 Public Works of the Senate a report regarding
4 the progress and challenges in the transition
5 from paper to digital maps and a timetable for
6 completion of the digitization of all maps re-
7 lated to the System.”.

8 **SEC. 4. REPEAL OF REPORT.**

9 Section 3 of Public Law 109–226 is repealed.
