A BILL

To extend certain provisions of the Caribbean Basin Economic Recovery Act until September 30, 2030, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Extension of the Carib-
5 bean Basin Economic Recovery Act”.

1 **SEC. 2. EXTENSION OF THE CARIBBEAN BASIN ECONOMIC**
2 **RECOVERY ACT.**

3 Section 213 of the Caribbean Basin Economic Recov-
4 ery Act (19 U.S.C. 2703) is amended as follows:

5 (1) **EXTENSION FOR CERTAIN KNIT APPAREL**
6 **ARTICLES.**—In clause (iii) of subsection (b)(2)(A)—

7 (A) in subclause (II)(cc), by striking “Sep-
8 tember 30, 2020” and inserting “September 30,
9 2030”; and

10 (B) in subclause (IV)(dd), by striking
11 “September 30, 2020” and inserting “Sep-
12 tember 30, 2030”.

13 (2) **EXTENSION OF LIMITATION WITH RESPECT**
14 **TO CERTAIN OTHER APPAREL ARTICLES.**—In clause
15 (iv)(II) of such subsection, by striking “18” and in-
16 serting “28”.

17 (3) **EXTENSION OF TRANSITION PERIOD.**—In
18 subsection (b)(5)(D)(i), by striking “September 30,
19 2020” and inserting “September 30, 2030”.

20 **SEC. 3. CUSTOMS USER FEES.**

21 (a) **IN GENERAL.**—Section 13031(j)(3) of the Con-
22 solidated Omnibus Budget Reconciliation Act of 1985 (19
23 U.S.C. 58c(j)(3)) is amended—

24 (1) in subparagraph (A), by striking “Sep-
25 tember 30, 2029” and inserting “October 21,
26 2029”; and

1 (2) in subparagraph (B)(i), by striking “Sep-
2 tember 30, 2029” and inserting “October 21,
3 2029”.

4 (b) RATE FOR MERCHANDISE PROCESSING FEES.—
5 Section 503 of the United States–Korea Free Trade
6 Agreement Implementation Act (Public Law 112–41; 19
7 U.S.C. 3805 note) is amended by striking “September 30,
8 2029” and inserting “October 21, 2029”.

9 **SEC. 4. DETERMINATION OF BUDGETARY EFFECTS.**

10 The budgetary effects of this Act, for the purpose of
11 complying with the Statutory Pay-As-You-Go Act of 2010,
12 shall be determined by reference to the latest statement
13 titled “Budgetary Effects of PAYGO Legislation” for this
14 Act, submitted for printing in the Congressional Record
15 by the Chairman of the House Budget Committee, pro-
16 vided that such statement has been submitted prior to the
17 vote on passage.
