A BILL

To direct the Secretary of the Interior to conduct a special resource study of the site of the Kettle Creek Battlefield in Wilkes County, Georgia, and adjacent property, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. KETTLE CREEK BATTLEFIELD SURVEY.**

4 (a) *SHORT TITLE.*—*This section may be cited as the*
5 *“Kettle Creek Battlefield Survey Act”.*

6 (b) *RECONNAISSANCE SURVEY.*—

7 (1) *SURVEY.*—*The Secretary of the Interior (re-*
8 *ferred to in this section as the “Secretary”) shall con-*
9 *duct a reconnaissance survey of the site of the Kettle*
10 *Creek Battlefield in Wilkes County, Georgia, and ad-*
11 *acent property (referred to in this section as the*
12 *“site”).*

13 (2) *REQUIREMENTS FOR SURVEY.*—*In con-*
14 *ducting the survey under paragraph (1), the Sec-*
15 *retary shall evaluate the likelihood that resources*
16 *within the site boundary would meet the four criteria*
17 *for new parklands—*

18 (A) *national significance;*

19 (B) *suitability;*

20 (C) *feasibility; and*

21 (D) *need for National Park Service man-*
22 *agement.*

23 (3) *REPORT.*—*Not later than 1 year after the*
24 *date on which funds are made available to carry out*
25 *the survey under paragraph (1), the Secretary shall*

1 *submit to the Committee on Natural Resources of the*
2 *House of Representatives and the Committee on En-*
3 *ergy and Natural Resources of the Senate a report*
4 *that describes—*

5 *(A) the results of the survey; and*

6 *(B) any conclusions and recommendations*
7 *of the Secretary.*

Amend the title so as to read: “A bill to direct the Secretary of the Interior to conduct a reconnaissance survey of the site of the Kettle Creek Battlefield in Wilkes County, Georgia, and adjacent property, and for other purposes.”.
