A BILL

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Health Care Access
5 for Urban Native Veterans Act”.

6 **SEC. 2. SHARING ARRANGEMENTS WITH FEDERAL AGEN-**
7 **CIES.**

8 Section 405 of the Indian Health Care Improvement
9 Act (25 U.S.C. 1645) is amended—

10 (1) in subsection (a)(1), by inserting “urban In-
11 dian organizations,” before “and tribal organiza-
12 tions”; and

13 (2) in subsection (c)—

14 (A) by inserting “urban Indian organiza-
15 tion,” before “or tribal organization”; and

16 (B) by inserting “an urban Indian organi-
17 zation,” before “or a tribal organization”.
