A BILL

To redesignate the Jimmy Carter National Historic Site as
the “Jimmy Carter National Historical Park”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Jimmy Carter National
5 Historical Park Redesignation Act”.

6 **SEC. 2. DESIGNATION OF JIMMY CARTER NATIONAL HIS-**
7 **TORICAL PARK.**

8 (a) IN GENERAL.—The Jimmy Carter National His-
9 toric Site shall be known and designated as the “Jimmy
10 Carter National Historical Park”.

11 (b) AMENDMENTS TO PUBLIC LAW 100–206.—Pub-
12 lic Law 100–206 (54 U.S.C. 320101 note; 101 Stat.
13 1434) is amended—

14 (1) in section 1(a), in the matter preceding
15 paragraph (1), by striking “National Historic Site”
16 and inserting “National Historical Park”;

17 (2) in section 3—

18 (A) in subsection (a), by striking “provi-
19 sions of law generally applicable to national his-
20 toric sites” and inserting “provisions of law
21 generally applicable to units of the National
22 Park System”; and

23 (B) in subsection (d), in the second sen-
24 tence, by striking “National Historic Site” and
25 inserting “National Historical Park”;

1 (3) in section 6(2), by striking “National His-
2 toric Site” and inserting “National Historical
3 Park”;

4 (4) by striking “historic site” each place it ap-
5 pears and inserting “historical park”;

6 (5) by striking “historic site” each place it ap-
7 pears and inserting “historical park”; and

8 (6) by striking “Historic Site” each place it ap-
9 pears and inserting “Historical Park”.

10 (c) REFERENCES.—Any reference in any law, regula-
11 tion, document, record, map, or other paper of the United
12 States to the Jimmy Carter National Historic Site shall
13 be considered to be a reference to the “Jimmy Carter Na-
14 tional Historical Park”.
