Mr. TESTER (for himself and Mr. MORAN) introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To authorize major medical facility projects of the Department of Veterans Affairs for fiscal year 2021.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Major Medical Facility
5 Authorization Act of 2021”.

6 **SEC. 2. AUTHORIZATION OF MAJOR MEDICAL FACILITY**
7 **PROJECTS OF DEPARTMENT OF VETERANS**
8 **AFFAIRS FOR FISCAL YEAR 2021.**

9 (a) IN GENERAL.—The Secretary of Veterans Affairs
10 may carry out the following major medical facility projects

1 in fiscal year 2021 at the locations specified and in an
2 amount for each project not to exceed the amount speci-
3 fied for such location:

4 (1) Construction of an outpatient clinic and na-
5 tional cemetery in Alameda, California, in an
6 amount not to exceed \$266,200,000.

7 (2) Construction of a new specialty care build-
8 ing 201 in American Lake, Washington, in an
9 amount not to exceed \$110,600,000.

10 (3) Construction of a community living center
11 and renovation of domiciliary and outpatient facili-
12 ties in Canandaigua, New York, in an amount not
13 to exceed \$383,741,000.

14 (4) Construction of a spinal cord injury center
15 in Dallas, Texas, in an amount not to exceed
16 \$249,000,000.

17 (5) Realignment and closure of the Livermore
18 Campus in Livermore, California, in an amount not
19 to exceed \$455,000,000.

20 (6) Seismic corrections to the mental health
21 and community living center in Long Beach, Cali-
22 fornia, in an amount not to exceed \$367,300,000.

23 (7) Construction of a spinal cord injury build-
24 ing with a community living center, including a

1 parking garage, in San Diego, California, in an
2 amount not to exceed \$252,100,000.

3 (b) AUTHORIZATION OF APPROPRIATIONS.—There is
4 authorized to be appropriated to the Secretary of Veterans
5 Affairs for fiscal year 2021 or the year in which funds
6 are appropriated for the Construction, Major Projects ac-
7 count, \$2,083,941,000 for the projects authorized in sub-
8 section (a).
