A BILL

To improve the methods by which the Secretary of Veterans Affairs identifies health care providers that are not eligible to participate in the Veterans Community Care Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Improving Oversight
- 5 of Veterans Community Care Providers Act of 2022".

1	SEC. 2. IDENTIFICATION OF HEALTH CARE PROVIDERS
2	THAT ARE NOT ELIGIBLE TO PARTICIPATE IN
3	VETERANS COMMUNITY CARE PROGRAM.
4	(a) Plan.—
5	(1) Requirement.—Beginning not later than
6	90 days after the date of the enactment of this Act,
7	the Secretary of Veterans Affairs, acting through
8	the Under Secretary for Health, shall carry out a
9	plan to improve the methods by which the Secretary
10	identifies health care providers that are not eligible
11	to participate in the Veterans Community Care Pro-
12	gram.
13	(2) Matters included.—The plan under
14	paragraph (1) shall include the following:
15	(A) Modifying the standard operating pro-
16	cedures of the Office of Community Care of the
17	Veterans Health Administration regarding the
18	exclusion of health care providers from partici-
19	pating in the Veterans Community Care Pro-
20	gram to require the automated continuous
21	matching of health care providers in the Pro-
22	vider Profile Management System of the Vet-
23	erans Health Administration, or such successor
24	system, with covered data systems using mul-
25	tiple unique identifiers, including taxpaver iden-

1	tification number, national provider identifier,
2	Social Security number, and date of birth.
3	(B) A fraud risk analysis conducted by the
4	Office of Community Care regarding the exclu-
5	sion of health care providers from participating
6	in the Veterans Community Care Program that
7	includes—
8	(i) an assessment of the likelihood and
9	impact of inherent fraud risks relating to
10	the self-certification of State licenses and
11	addresses provided by health care pro-
12	viders;
13	(ii) a determination of the fraud risk
14	tolerance; and
15	(iii) an examination of the suitability
16	of existing fraud controls.
17	(C) Any other matters the Under Sec-
18	retary determines will improve the oversight of
19	health care providers participating in the Vet-
20	erans Community Care Program.
21	(b) Certification.—Not later than 270 days after
22	the date of the enactment of this Act, the Secretary shall
23	certify to the Committees on Veterans' Affairs of the
24	House of Representatives and the Senate that the Sec-
25	retary has implemented the plan under subsection (a).

1	(c) Reports.—
2	(1) Initial report.—Not later than one year
3	after the date of the enactment of this Act, the Sec-
4	retary shall submit to the Committees on Veterans'
5	Affairs of the House of Representatives and the Sen-
6	ate a report that—
7	(A) describes the progress the Under Sec-
8	retary has made in carrying out the plan under
9	subsection (a); and
10	(B) includes recommendations for legisla-
11	tive action to further improve the methods by
12	which the Secretary identifies health care pro-
13	viders that are not eligible to participate in the
14	Veterans Community Care Program.
15	(2) UPDATE.—Not later than two years after
16	the date on which the Secretary submits the report
17	under paragraph (1), the Secretary shall submit to
18	the Committees on Veterans' Affairs of the House of
19	Representatives and the Senate an update to the re-
20	port.
21	(d) Definitions.—In this section:
22	(1) The term "covered data systems" means
23	the following:

1	(A) The List of Excluded Individuals/Enti-
2	ties of the Office of Inspector General of the
3	Department of Health and Human Services.
4	(B) The System for Award Management
5	Exclusions list described in part 9 of title 48
6	Code of Federal Regulations, and part 180 of
7	title 2 of such Code, or successor regulations.
8	(C) The monthly deactivation file of the
9	National Plan and Provider Enumeration Sys-
10	tem of the Centers for Medicare & Medicaid
11	Services.
12	(D) The National Practitioner Data Bank
13	established pursuant to the Health Care Quality
14	Improvement Act of 1986 (42 U.S.C. 11101 et
15	seq.).
16	(2) The term "Veterans Community Care Pro-
17	gram" means the program established under section
18	1703 of title 38, United States Code.
