2           **CONTINUING APPROPRIATIONS ACT, 2024**

3           SEC. 101. The Continuing Appropriations Act, 2024  
4 (division A of Public Law 118–15) is further amended—

5           (1) by striking the date specified in section  
6           106(3) and inserting “March 8, 2024”;

7           (2) by striking the date specified in section  
8           106(4) and inserting “March 1, 2024”;

9           (3) in section 123, by striking “94 days” and  
10          inserting “129 days” and by striking “94-day” and  
11          inserting “129-day”;

12          (4) in section 124, by striking “\$663,070,000”  
13          and inserting “\$2,199,260,000”; and

14          (5) by adding after section 146 the following  
15          new sections:

16          “SEC. 147. (a) Amounts made available by section  
17          101 for ‘Department of Energy—Atomic Energy Defense  
18          Activities—National Nuclear Security Administration—  
19          Weapons Activities’ may be apportioned up to the rate for  
20          operations necessary to mitigate issuing WARN notices  
21          for ‘06–D–141 Uranium Processing Facility, Y–12’ in an  
22          amount not to exceed \$760,000,000.

23          “(b) The Director of the Office of Management and  
24          Budget shall notify the Committees on Appropriations of  
25          the House of Representatives and the Senate not later

1 than 3 days after each use of the authority provided in  
2 this section, and the Secretary of Energy shall provide a  
3 weekly report to the Committees specifying the obligations  
4 incurred for the purposes specified in subsection (a) with  
5 amounts made available in this Act.

6       “SEC. 148. Amounts made available by section 101  
7 for ‘Department of Transportation—Federal Aviation Ad-  
8 ministration—Operations’ may be apportioned up to the  
9 rate for operations necessary to fund mandatory pay in-  
10 creases and other inflationary adjustments, to maintain  
11 and improve air traffic services, to hire and train air traf-  
12 fic controllers, and to continue aviation safety oversight,  
13 while avoiding service reductions.”.

14       This division may be cited as the “Further Additional

21 the Statutory Pay-As-You-Go Act of 2010.

22           (b) **SENATE PAYGO SCORECARDS.**—The budgetary  
23 effects of this division shall not be entered on any PAYGO  
24 scorecard maintained for purposes of section 4106 of H.  
25 Con. Res. 71 (115th Congress).

1           (c) CLASSIFICATION OF BUDGETARY EFFECTS.—  
2 Notwithstanding Rule 3 of the Budget Scorekeeping  
3 Guidelines set forth in the joint explanatory statement of  
4 the committee of conference accompanying Conference Re-  
5 port 105–217 and section 250(c)(8) of the Balanced  
6 Budget and Emergency Deficit Control Act of 1985, the  
7 budgetary effects of this division shall not be estimated—  
8           (1) for purposes of section 251 of such Act;  
9           (2) for purposes of an allocation to the Com-  
10          mittee on Appropriations pursuant to section 302(a)  
11          of the Congressional Budget Act of 1974; and  
12           (3) for purposes of paragraph (4)(C) of section  
13          3 of the Statutory Pay-As-You-Go Act of 2010 as  
14          being included in an appropriation Act.
