# **A BILL**

To reauthorize the Morris K. Udall and Stewart L. Udall  
Trust Fund, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SEC. 1. SHORT TITLE.**

4        *This Act may be cited as the “Udall Foundation Reau-*  
5 *thorization Act of 2023”.*

6 **SEC. 2. INVESTMENT EARNINGS.**

7        *Section 8(b)(1) of the Morris K. Udall and Stewart*  
8 *L. Udall Foundation Act (20 U.S.C. 5606(b)(1)) is amend-*  
9 *ed by adding at the end the following: “Beginning on Octo-*  
10 *ber 1, 2023, and thereafter, interest earned from invest-*  
11 *ments made with any new appropriations to the Trust*  
12 *Fund shall only be available subject to appropriations and*  
13 *is authorized to be appropriated to carry out the provisions*  
14 *of this Act.”.*

15 **SEC. 3. REAUTHORIZATION OF THE UDALL FOUNDATION**  
16 **TRUST FUND.**

17        *Section 13 of the Morris K. Udall and Stewart L.*  
18 *Udall Foundation Act (20 U.S.C. 5609) is amended—*

19            *(1) in subsection (a), by striking “2023” and in-*  
20 *serting “2028”;*

21            *(2) in subsection (b), in the matter preceding*  
22 *paragraph (1), by striking “2023” and inserting*  
23 *“2028”; and*

24            *(3) in subsection (c), by striking “5-fiscal year*  
25 *period” and all that follows through the period at the*

1        *end and inserting “5-fiscal year period beginning*  
2        *with fiscal year 2024.”.*

3        **SEC. 4. AUDIT OF THE FOUNDATION.**

4        *Not later than 4 years after the date of enactment of*  
5        *this section, the Inspector General of the Department of the*  
6        *Interior shall complete an audit of the Morris K. Udall and*  
7        *Stewart L. Udall Foundation.*
