## 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Small Business Admin-
3	istration Rural Performance Report Act".
4	SEC. 2. SMALL BUSINESS RURAL PERFORMANCE REPORTS.
5	(a) Office of Rural Affairs Annual Perform-
6	ANCE REPORT.—Section 26 of the Small Business Act (15
7	U.S.C. 653) is amended by adding at the end the fol-
8	lowing:
9	"(d) Reports.—
10	"(1) Initial Report.—Not later than 90 days
11	after the date of the enactment of this subsection,
12	the Administrator shall make available on a website
13	of the Administration, and submit to the Committee
14	on Small Business of the House of Representatives
15	and the Committee on Small Business and Entrepre-
16	neurship of the Senate, a report on the activities of
17	the Office during the year preceding the date of the
18	report that includes the following elements:
19	"(A) How the Office is promoting financial

21	"(B) Annual statistics compiled pursuant

5	"(F) Details of any partnerships that the

10	"(G) The name of the director of the Of-
11	fice and the number of staff employed by the
12	Office.
13	"(2) Annual Report.—The Administrator

16	of the Small Business Administration budget for a
17	fiscal year (as submitted with the budget of the

2	PARTMENT OF AGRICULTURE REPORT.—Not later than
3	90 days after the date of the enactment of this Act, the
4	Administrator shall make available on a website of the Ad-
5	ministration and submit to the Committee on Small Busi-
6	ness of the House of Representatives and the Committee
7	on Small Business and Entrepreneurship of the Senate a
8	report on the MOU. Such report shall include a descrip-
9	tion of the following:
10	(1) How many working groups convened pursu-
11	ant to the MOU the Administration was part of and
12	if the Administration is still part of any such work-
13	ing groups.
14	(2) How many staff employed by the Adminis-
15	tration were and are still involved with a working
16	group convened pursuant to the MOU.
17	(3) The findings specified in clauses (i) through
18	(iv) of paragraph (1) of part 2 of the MOU.
19	(4) The findings specified in clauses (i) through
20	(iv) of paragraph (2) of part 2 of the MOU.
21	SEC. 3. DEFINITIONS.
22	In this Act:
23	(1) Administrator.—The term "Adminis-
24	trator' means the Administrator of the Small Busi-
25	ness Administration.

1	(2) Administration.—The term "Administra-
2	tion" means the Small Business Administration.
3	(3) MOU.—The term "MOU" means the
4	memorandum of understanding between the Depart-
5	ment of Agriculture and the Small Business Admin-
6	istration entered into on April 4, 2018, about col-
7	laborative efforts to promote stronger businesses and
8	agricultural economies in rural America.
9	SEC. 4. COMPLIANCE WITH CUTGO.

12	by this Act.
