## A BILL

To establish an Office of Native American Affairs within the Small Business Administration, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Native American En-  
5 trepreneurial Opportunity Act”.

6 **SEC. 2. OFFICE OF NATIVE AMERICAN AFFAIRS.**

7 The Small Business Act (15 U.S.C. 631 et seq.) is  
8 amended—

9 (1) by redesignating section 49 (15 U.S.C. 631  
10 note) as section 50; and

1           (2) by inserting after section 48 (15 U.S.C.  
2           657u) the following:

3   **“SEC. 49. OFFICE OF NATIVE AMERICAN AFFAIRS.**

4           “(a) DEFINITIONS.—In this section:

5           “(1) ASSISTANT ADMINISTRATOR.—The term  
6           ‘Assistant Administrator’ means the Assistant Ad-  
7           ministrators for Native American Affairs appointed  
8           under subsection (c).

9           “(2) INDIAN TRIBE.—The term ‘Indian Tribe’  
10          has the meaning given the term ‘Indian tribe’ in sec-  
11          tion 8(a)(13).

12          “(3) NATIVE HAWAIIAN ORGANIZATION.—The  
13          term ‘Native Hawaiian Organization’ has the mean-  
14          ing given the term in section 8(a)(15).

15          “(4) OFFICE.—The term ‘Office’ means the Of-  
16          fice of Native American Affairs described in this sec-  
17          tion.

18          “(b) ESTABLISHMENT.—

19          “(1) IN GENERAL.—There is established within  
20          the Administration the Office of Native American  
21          Affairs, which shall be responsible for establishing a  
22          working relationship with Indian Tribes and Native  
23          Hawaiian Organizations by targeting programs of  
24          the Administration relating to entrepreneurial devel-  
25          opment, contracting, and capital access to—

1           “(A) establish or expand small business  
2           concerns owned and controlled by individuals  
3           who are members of Indian Tribes or Native  
4           Hawaiian Organizations; and

5           “(B) promote economic development in In-  
6           dian country (as defined in section 1151 of title  
7           18, United States Code).

8           “(2) CONNECTION WITH OTHER PROGRAMS.—  
9           To the extent reasonable, the Office shall educate  
10          Indian Tribes and Native Hawaiian Organizations  
11          about programs administered by other Federal agen-  
12          cies related to the interests described in paragraph  
13          (1).

14          “(c) ASSISTANT ADMINISTRATOR.—The Office shall  
15          be headed by an Assistant Administrator for Native Amer-  
16          ican Affairs, who shall—

17                 “(1) be appointed by and report to the Admin-  
18                 istrator;

19                 “(2) have knowledge of Native American cul-  
20                 tures and experience providing culturally tailored  
21                 small business development assistance to Native  
22                 Americans;

23                 “(3) provide assistance to Indian Tribes and  
24                 Native Hawaiian Organizations and small business  
25                 concerns owned and controlled by individuals who

1 are members of Indian Tribes or Native Hawaiian  
2 Organizations;

3 “(4) formulate policies, and promote policies  
4 and existing programs, to better address the entre-  
5 preneurial, capital access, business development, and  
6 contracting needs of persons described in paragraph  
7 (3);

8 “(5) collaborate with Associate Administrators  
9 within the Administration and officials of other Fed-  
10 eral agencies to develop policies and plans to imple-  
11 ment programs of the Administration to holistically  
12 address the needs described in paragraph (4);

13 “(6) provide assistance, including grants, con-  
14 tracts, cooperative agreements, or other financial as-  
15 sistance, to Indian Tribes and Native Hawaiian Or-  
16 ganizations, or to private nonprofit organizations  
17 governed by members of Indian Tribes or Native  
18 Hawaiian Organizations that have the experience  
19 and capability to use the assistance to—

20 “(A) deploy training, counseling, work-  
21 shops, educational outreach, and supplier  
22 events; and

23 “(B) access the entrepreneurial, capital,  
24 and contracting programs of the Administra-  
25 tion;

1           “(7) assist the Administrator in conducting, or  
2           conduct, Tribal consultation to solicit input and fa-  
3           cilitate discussion of potential modifications to pro-  
4           grams and procedures of the Administration; and

5           “(8) recommend annual budgets for the Office.

6           “(d) REPORT TO CONGRESS.—On an annual basis  
7           until the termination date, the Assistant Administrator  
8           shall submit to Congress a report on the effectiveness of  
9           the Office of Native American Affairs that includes the  
10          number of clients served in Tribal communities, the num-  
11          ber of consultations conducted, and the number of  
12          trainings held in Tribal country.

13          “(e) TERMINATION.—The authority under this sec-  
14          tion shall terminate seven years after the date of the en-  
15          actment of this section.”.

16          **SEC. 3. COMPLIANCE WITH CUTGO.**

17          No additional amounts are authorized to be appro-  
18          priated to carry out this Act or the amendments made  
19          by this Act.
