A BILL

To direct the Secretary of the Interior and the Secretary of Agriculture to notify applicants of the completion status of right-of-way applications under section 501 of the Federal Land Policy and Management Act of 1976 and section 28 of the Mineral Leasing Act.

1 Be it enacted by the Senate and House of Representa-2 tives of the United States of America in Congress assembled, 3 SECTION 1. SHORT TITLE. 4 This Act may be cited as the "Right-Of-Way Applica-5 tion Transparency and Accountability Act" or the 6 "ROWATA Act". 7 SEC. 2. DETERMINATION REGARDING RIGHTS-OF-WAY. 8 (a) NOTICE.—Not later than 90 days after the Sec-9 retary concerned receives an application to grant a right-10 of-way, the Secretary concerned shall— 11 (1) notify the applicant as to whether the appli-12 cation is complete; or 13 (2) notify the applicant that information is 14 missing and specify any information that is required 15 to be submitted for the application to be complete. 16 (b) DEFINITIONS.—In this Act: 17 RIGHT-OF-WAY.—The term "right-of-way" (1)18 means----19 (A) a right-of-way issued, granted, or re-20 newed under section 501 of the Federal Land 21 Policy and Management Act of 1976 (43 U.S.C. 22 1761); or 23 (B) a right-of-way granted under section 28 24 of the Mineral Leasing Act (30 U.S.C. 185).
