A BILL

To amend the Neotropical Migratory Bird Conservation Act to make improvements to that Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Migratory Birds of the
- 5 Americas Conservation Enhancements Act of 2023".
- 6 SEC. 2. NEOTROPICAL MIGRATORY BIRD CONSERVATION
- 7 ACT AMENDMENTS.
- 8 (a) FEDERAL SHARE.—Section 5(e)(1) of the
- 9 Neotropical Migratory Bird Conservation Act (16 U.S.C.
- 10 6104(e)(1)) is amended by striking "25 percent" and insert-
- 11 ing "33.3 percent".
- 12 (b) Cooperation.—Section 7 of the Neotropical Mi-
- 13 gratory Bird Conservation Act (16 U.S.C. 6106) is amend-
- 14 ed by adding at the end the following:
- 15 "(c) Report to Congress.—Not later than 180 days
- 16 after the date of the enactment of the Migratory Birds of
- 17 the Americas Conservation Enhancements Act of 2023, the
- 18 Secretary shall submit to the Committee on Environment
- 19 and Public Works of the Senate and the Committee on Nat-
- 20 ural Resources of the House of Representatives a report de-
- 21 scribing the implementation of subsection (b) by the Sec-
- 22 retary, which shall include, if applicable, a description of
- 23 the composition of the advisory group convened under para-
- 24 graph (1) of that subsection.".

10	(B) by redesignating paragraphs (2)
11	through (5) as paragraphs (1) through (4), re-
12	spectively.
13	(2) Cooperation.—Section 7(b)(1) of the
14	Neotropical Migratory Bird Conservation Act (16
15	$U.S.C.\ 6106(b)(1))$ is amended in the second sentence
16	by adding a period at the end.
