2	This Act may be cited as the "Clear Communication

4	SEC. 2. INDEPENDENT ASSESSMENT OF NOTICES THAT THE
5	SECRETARY OF VETERANS AFFAIRS SENDS

7	(a) AGREEMENT.—Not later than 30 days after the
8	date of the enactment of this Act, the Secretary of Vet-
9	erans Affairs shall seek to enter into an agreement with

12	(b) Assessment.—An FFRDC that enters to an
