## A BILL

To require the Comptroller General of the United States to conduct a review of the Mid-Atlantic River Basin Commissions, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Mid-Atlantic River
5	Basin Commissions Review Act".
6	SEC. 2. MID-ATLANTIC RIVER BASIN COMMISSIONS.
7	(a) GAO REPORT.—
8	(1) IN GENERAL.—Not later than 1 year after
9	the date of enactment of this Act, the Comptroller
10	General of the United States shall initiate a review
11	of the Mid-Atlantic River Basin Commissions.
12	(2) Requirements.—In conducting the review
13	under paragraph (1), the Comptroller General
14	shall—
15	(A) review the ethics policies and practices
16	of each Mid-Atlantic River Basin Commission;
17	(B) review the practices each Mid-Atlantic
18	River Basin Commission uses to communicate
19	with the general public;
20	(C) review current Federal responsibilities
21	at each Mid-Atlantic River Basin Commission,
22	including the types of actions taken by relevant
23	Federal agencies in carrying out such respon-
24	sibilities;

1	(D) describe the level and sources of Fed-
2	eral and State funding received by each Mid-At-
3	lantic River Basin Commission;
4	(E) identify duties and responsibilities of
5	each Mid-Atlantic River Basin Commission that
6	may be duplicative of, or overlap with, other
7	Federal authorities; and
8	(F) review policies and best practices of
9	each Mid-Atlantic River Basin Commission for
10	reporting activities of the Commission.
11	(3) Report.—Upon completion of the review
12	conducted under paragraph (1), the Comptroller
13	General shall submit to the Committee on Transpor-
14	tation and Infrastructure of the House of Represent-
15	atives and the Committee on Environment and Pub-
16	lic Works of the Senate a report containing—
17	(A) the findings of such review; and
18	(B) any recommendations, including any
19	recommendations for statutory or administra-
20	tive changes or changes to ethics policies and
21	practices, to increase the transparency or con-
22	gressional oversight of the Mid-Atlantic River
23	Basin Commissions.
24	(b) Plan for Compliance.—Not later than 90 days
25	after the Comptroller General submits the report required

1	under subsection (a)(3), and annually thereafter for five
2	years, each Mid-Atlantic River Basin Commission shall
3	submit to the Committee on Transportation and Infra-
4	structure of the House of Representatives and the Com-
5	mittee on Environment and Public Works of the Senate
6	a plan detailing actions such Commission has taken to
7	comply with the recommendations contained in such re-
8	port.
9	(c) Mid-Atlantic River Basin Commission De-
10	FINED.—In this section, the term "Mid-Atlantic River
11	Basin Commission" means—
12	(1) the Susquehanna River Basin Commission
13	created by the Susquehanna River Basin Compact to
14	which consent was given by Public Law 91–575 (84
15	Stat. 1509);
16	(2) the Delaware River Basin Commission cre-
17	ated by the Delaware River Basin Compact to which
18	consent was given by Public Law 87–328 (75 Stat.
19	688); and
20	(3) the Interstate Commission on the Potomac
21	River Basin created by the Potomac River Basin
22	Compact to which consent was given by Public Law
23	91–407 (84 Stat. 856).
