# **A BILL**

To improve the health and resiliency of giant sequoias, and  
for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4        (a) *SHORT TITLE.*—*This Act may be cited as the*  
5 *“Save Our Sequoias Act”.*

6        (b) *TABLE OF CONTENTS.*—*The table of contents for*

8 **SEC. 2. DEFINITIONS.**

9        *In this Act:*

10            (1) *ASSESSMENT.*—*The term “Assessment”*  
11 *means the Giant Sequoia Health and Resiliency As-*  
12 *essment required by section 5.*

13            (2) *COALITION.*—*The term “Coalition” means*  
14 *the Giant Sequoia Lands Coalition codified under*  
15 *section 4(a).*

16            (3) *COLLABORATIVE PROCESS.*—*The term “col-*  
17 *laborative process” means a collaborative process as*  
18 *described in section 4003(b)(2) of the Omnibus Public*  
19 *Land Management Act of 2009 (16 U.S.C.*  
20 *7303(b)(2)).*

1           (4) *COVERED NATIONAL FOREST SYSTEM*  
2           *LANDS.*—*The term “covered National Forest System*  
3           *lands” means the proclaimed National Forest System*  
4           *lands reserved or withdrawn from the public domain*  
5           *of the United States covering the Sequoia National*  
6           *Forest and Giant Sequoia National Monument, Si-*  
7           *erra National Forest, and Tahoe National Forest.*

8           (5) *COVERED PUBLIC LANDS.*—*The term “cov-*  
9           *ered public lands” means—*

10                   (A) *the Case Mountain Extensive Recre-*  
11                   *ation Management Area in California managed*  
12                   *by the Bureau of Land Management; and*

13                   (B) *Kings Canyon National Park, Sequoia*  
14                   *National Park, and Yosemite National Park in*  
15                   *California managed by the National Park Serv-*  
16                   *ice.*

17           (6) *GIANT SEQUOIA.*—*The term “giant sequoia”*  
18           *means a tree of the species Sequoiadendron*  
19           *giganteum.*

20           (7) *PROTECTION PROJECT.*—*The term “ Protec-*  
21           *tion Project” means a Giant Sequoia Protection*  
22           *Project carried out under section 6.*

23           (8) *REFORESTATION.*—*The term “reforestation”*  
24           *means the act of renewing tree cover, taking into con-*

1        *sideration species composition and resilience, by es-*  
2        *tablishing young trees through—*

3                *(A) natural regeneration;*

4                *(B) natural regeneration with site prepara-*  
5        *tion and vegetation competition control; or*

6                *(C) planting or direct seeding.*

7                *(9) REHABILITATION.—The term “rehabilita-*  
8        *tion” means any action taken during the 5-year pe-*  
9        *riod beginning on the last day of a wildland fire to*  
10       *repair or improve fire-impacted lands which are un-*  
11       *likely to recover to management-approved conditions.*

12               *(10) RELEVANT CONGRESSIONAL COMMITTEES.—*  
13       *The term “relevant Congressional Committees”*  
14       *means—*

15               *(A) the Committees on Natural Resources,*  
16       *Agriculture, and Appropriations of the House of*  
17       *Representatives; and*

18               *(B) the Committees on Energy and Natural*  
19       *Resources, Agriculture, Nutrition, and Forestry,*  
20       *and Appropriations of the Senate.*

21               *(11) RESPONSIBLE OFFICIAL.—The term “re-*  
22       *sponsible official” means an employee of the Depart-*  
23       *ment of the Interior or Forest Service who has the au-*  
24       *thority to make and implement a decision on a pro-*  
25       *posed action.*

1           (12) *SECRETARY*.—The term “Secretary” means  
2           the Secretary of the Interior.

3           (13) *SECRETARY CONCERNED*.—The term “Sec-  
4           retary concerned” means—

5                   (A) the Secretary of Agriculture, with re-  
6                   spect to covered National Forest System lands, or  
7                   their designee; and

8                   (B) the Secretary of the Interior, with re-  
9                   spect to covered public lands, or their designee.

10          (14) *STRATEGY*.—The term “Strategy” means  
11          the Giant Sequoia Reforestation and Rehabilitation  
12          Strategy established under section 7.

13          (15) *STRIKE TEAM*.—The term “Strike Team”  
14          means a Giant Sequoia Strike Team established  
15          under section 8.

16          (16) *TRIBE*.—The term “Tribe” means the Tule  
17          River Indian Tribe of the Tule River Reservation,  
18          California.

19   **SEC. 3. SHARED STEWARDSHIP AGREEMENT FOR GIANT SE-**  
20                   **QUOIAS.**

21          (a) *IN GENERAL*.—Not later than 90 days after receiv-  
22          ing a request from the Governor of the State of California  
23          or the Tribe, the Secretary shall enter into or expand an  
24          existing shared stewardship agreement or enter into a simi-  
25          lar agreement with the Secretary of Agriculture, the Gov-

1 *error of the State of California, and the Tribe to jointly*  
2 *carry out the short-term and long-term management and*  
3 *conservation of giant sequoias.*

4 *(b) PARTICIPATION.—*

5 *(1) IN GENERAL.—If the Secretary has not re-*  
6 *ceived a request from the Governor of the State of*  
7 *California or the Tribe under subsection (a) before the*  
8 *date that is 90 days after the date of enactment of*  
9 *this Act, the Secretary shall enter into the agreement*  
10 *under subsection (a) and jointly implement such*  
11 *agreement with the Secretary of Agriculture.*

12 *(2) FUTURE PARTICIPATION.—If the Secretary*  
13 *receives a request from the Governor of the State of*  
14 *California or the Tribe any time after entering into*  
15 *the agreement with the Secretary of Agriculture under*  
16 *paragraph (1), the Secretary shall accept the Gov-*  
17 *ernor of the State of California or the Tribe as a*  
18 *party to such agreement.*

19 **SEC. 4. GIANT SEQUOIA LANDS COALITION.**

20 *(a) CODIFICATION.—The Coalition is the entity estab-*  
21 *lished under the charter titled “Giant Sequoia Lands Coali-*  
22 *tion Charter” (or successor charter) signed during the pe-*  
23 *riod beginning June 2, 2022 and ending August 2, 2022*  
24 *by each of the following:*

1           (1) *The National Park Service, representing Se-*  
2           *quoia and Kings Canyon National Parks.*

3           (2) *The National Park Service, representing Yo-*  
4           *osemite National Park.*

5           (3) *The Forest Service, representing Sequoia Na-*  
6           *tional Forest and Giant Sequoia National Monument.*

7           (4) *The Forest Service, representing Sierra Na-*  
8           *tional Forest.*

9           (5) *The Forest Service, representing Tahoe Na-*  
10          *tional Forest.*

11          (6) *The Bureau of Land Management, rep-*  
12          *resenting Case Mountain Extensive Recreation Man-*  
13          *agement Area.*

14          (7) *The Tribe, representing the Tule River In-*  
15          *dian Reservation.*

16          (8) *The State of California, representing*  
17          *Calaveras Big Trees State Park.*

18          (9) *The State of California, representing Moun-*  
19          *tain Home Demonstration State Forest.*

20          (10) *The University of California, Berkeley, rep-*  
21          *resenting Whitaker's Research Forest.*

22          (11) *The County of Tulare, California, rep-*  
23          *resenting Balch Park.*

24          (b) *DUTIES.—In addition to the duties specified in the*  
25          *charter referenced in subsection (a), the Coalition shall—*

- 1           (1) *produce the Assessment under section 5;*
- 2           (2) *observe implementation, and provide policy*  
3 *recommendations to the Secretary concerned, with re-*  
4 *spect to—*
- 5                 (A) *Protection Projects carried out under*  
6 *section 6; and*
- 7                 (B) *the Strategy established under section 7;*
- 8           (3) *facilitate collaboration and coordination on*  
9 *Protection Projects, particularly projects that cross*  
10 *jurisdictional boundaries;*
- 11           (4) *facilitate information sharing, including best*  
12 *available science as described in section 5(d) and*  
13 *mapping resources; and*
- 14           (5) *support the development and dissemination*  
15 *of educational materials and programs that inform*  
16 *the public about the threats to the health and resil-*  
17 *ency of giant sequoia groves and actions being taken*  
18 *to reduce the risk to such groves from high-severity*  
19 *wildfire, insects, and drought.*
- 20           (c) *ADMINISTRATIVE SUPPORT, TECHNICAL SERVICES,*  
21 *AND STAFF SUPPORT.—The Secretary shall make personnel*  
22 *of the Department of the Interior available to the Coalition*  
23 *for administrative support, technical services, development*  
24 *and dissemination of educational materials, and staff sup-*

1 *port that the Secretary determines necessary to carry out*  
2 *this section.*

3 *(d) PUBLIC MEETING REQUIREMENT.—*

4 *(1) IN GENERAL.—Except as provided in para-*  
5 *graph (2), the Coalition shall hold not less than one*  
6 *meeting annually, which shall be open to the public.*

7 *(2) CLOSED SESSIONS.—The Coalition may close*  
8 *portions of a meeting to the public only when discus-*  
9 *sion will involve—*

10 *(A) sensitive law enforcement, security, or*  
11 *emergency response matters, the public disclosure*  
12 *of which would compromise public safety; or*

13 *(B) confidential commercial information,*  
14 *private property information, or landowner in-*  
15 *formation.*

16 **SEC. 5. GIANT SEQUOIA HEALTH AND RESILIENCY ASSESS-**  
17 **MENT.**

18 *(a) IN GENERAL.—Not later than 6 months after the*  
19 *date of the enactment of this Act, the Coalition shall submit*  
20 *to the relevant Congressional Committees a Giant Sequoia*  
21 *Health and Resiliency Assessment that, based on the best*  
22 *available science—*

23 *(1) identifies—*

24 *(A) each giant sequoia grove that has expe-*  
25 *rienced a—*

- 1                   (i) stand-replacing disturbance; or
- 2                   (ii) disturbance but continues to have
- 3 living giant sequoias within the grove, in-
- 4 cluding identifying the tree mortality and
- 5 regeneration of giant sequoias within such
- 6 grove;
- 7                   (B) each giant sequoia grove that is at high
- 8 risk of experiencing a stand-replacing disturb-
- 9 ance;
- 10                  (C) lands—
- 11                   (i) contiguous or adjacent to giant se-
- 12 quoaia groves that are at risk of experiencing
- 13 high-severity wildfires that could adversely
- 14 impact such giant sequoia groves; or
- 15                   (ii) in which the placement of fuel
- 16 breaks could reduce the risk of high-severity
- 17 wildfires that could adversely impact giant
- 18 sequoia groves; and
- 19                   (D) each giant sequoia grove that has expe-
- 20 rienced a disturbance and is unlikely to natu-
- 21 rally regenerate and is in need of reforestation;
- 22                  (2) analyzes the resiliency of each giant sequoia
- 23 grove to threats, such as—
- 24                   (A) high-severity wildfire;
- 25                   (B) insects, including beetle kill; and

1                   (C) drought;

2                   (3) examines how historical, Tribal, or current  
3 approaches to wildland fire suppression and forest  
4 management activities across various jurisdictions  
5 have impacted the health and resiliency of giant se-  
6 quoa groves with respect to—

7                   (A) high-severity wildfires;

8                   (B) insects, including beetle kill; and

9                   (C) drought; and

10                  (4) includes program and policy recommenda-  
11 tions that address—

12                   (A) options to enhance communication, co-  
13 ordination, and collaboration, particularly for  
14 cross-boundary projects, to improve the health  
15 and resiliency of giant sequoias; and

16                   (B) research gaps that should be addressed  
17 to improve the best available science on the giant  
18 sequoias.

19                  (b) ANNUAL UPDATES.—Not later than 1 year after  
20 the submission of the Assessment under subsection (a), and  
21 annually thereafter, the Coalition shall submit an updated  
22 Assessment to the relevant Congressional Committees that—

23                   (1) includes any new data, information, or best  
24 available science that has changed or become available  
25 since the previous Assessment was submitted;

1           (2) *with respect to Protection Projects—*

2                   (A) *includes information on the number of*  
3 *Protection Projects initiated the previous year*  
4 *and the estimated timeline for completing those*  
5 *projects;*

6                   (B) *includes information on the number of*  
7 *Protection Projects planned in the upcoming*  
8 *year and the estimated timeline for completing*  
9 *those projects;*

10                  (C) *provides status updates and long-term*  
11 *monitoring reports on giant sequoia groves after*  
12 *the completion of Protection Projects; and*

13                  (D) *if the Secretary concerned failed to re-*  
14 *duce hazardous fuels in at least 3 giant sequoia*  
15 *groves in the previous year, a written expla-*  
16 *nation that includes—*

17                           (i) *a detailed explanation of what im-*  
18 *pediments resulted in failing to reduce haz-*  
19 *ardous fuels in at least 3 giant sequoia*  
20 *groves; and*

21                           (ii) *a detailed explanation of what ac-*  
22 *tions the Secretary concerned is taking to*  
23 *ensure that hazardous fuels are reduced in*  
24 *at least 3 giant sequoia groves the following*  
25 *year; and*

1           (3) *with respect to reforestation and rehabilita-*  
2           *tion of giant sequoias—*

3                   (A) *contains updates on the implementation*  
4                   *of the Strategy under section 7, including grove-*  
5                   *level data on reforestation and rehabilitation ac-*  
6                   *tivities; and*

7                   (B) *provides status updates and monitoring*  
8                   *reports on giant sequoia groves that have experi-*  
9                   *enced reforestation or rehabilitation as part of*  
10                  *the Strategy under section 7.*

11           (c) *DASHBOARD.—*

12                   (1) *REQUIREMENT TO MAINTAIN.—The Coalition*  
13                   *shall create and maintain a website that—*

14                           (A) *publishes the Assessment, annual up-*  
15                           *dates to the Assessment, and other educational*  
16                           *materials developed by the Coalition;*

17                           (B) *contains searchable information about*  
18                           *individual giant sequoia groves, including the—*

19                                   (i) *resiliency of such groves to threats*  
20                                   *described in paragraphs (1) and (2) of sub-*  
21                                   *section (a);*

22                                   (ii) *Protection Projects that have been*  
23                                   *proposed, initiated, or completed in such*  
24                                   *groves; and*

1                   (iii) reforestation and rehabilitation  
2                   activities that have been proposed, initiated,  
3                   or completed in such groves; and

4                   (C) maintains a searchable database to  
5                   track—

6                   (i) the status of Federal environmental  
7                   reviews and authorizations for specific Pro-  
8                   tection Projects and reforestation and reha-  
9                   bilitation activities; and

10                  (ii) the projected cost of Protection  
11                  Projects and reforestation and rehabilita-  
12                  tion activities.

13                  (2) *SEARCHABLE DATABASE.*—The Coalition  
14                  shall include information on the status of Protection  
15                  Projects in the searchable database created under  
16                  paragraph (1)(C), including—

17                  (A) a comprehensive permitting timetable;

18                  (B) the status of the compliance of each lead  
19                  agency, cooperating agency, and participating  
20                  agency with the permitting timetable;

21                  (C) any modifications of the permitting  
22                  timetable required under subparagraph (A), in-  
23                  cluding an explanation as to why the permitting  
24                  timetable was modified; and

1                   (D) information about project-related public  
2 meetings, public hearings, and public comment  
3 periods, which shall be presented in English and  
4 the predominant language of the community or  
5 communities most affected by the project, as that  
6 information becomes available.

7           (d) *BEST AVAILABLE SCIENCE*.—In utilizing the best  
8 available science for the Assessment, the Coalition shall in-  
9 clude—

10           (1) data and peer-reviewed research from aca-  
11 demic institutions with a demonstrated history of  
12 studying giant sequoias and with experience ana-  
13 lyzing distinct management strategies to improve  
14 giant sequoia resiliency;

15           (2) traditional ecological knowledge from the  
16 Tribe related to improving the health and resiliency  
17 of giant sequoia groves; and

18           (3) data from Federal, State, Tribal, and local  
19 governments or agencies, and other interested stake-  
20 holders with a demonstrated history of studying giant  
21 sequoias and with experience analyzing distinct man-  
22 agement strategies to improve giant sequoia resil-  
23 iency.

24           (e) *TECHNOLOGY IMPROVEMENTS*.—In carrying out  
25 this section, the Secretary may enter into memorandums

1 *of understanding or agreements with other Federal agencies*  
2 *or departments, State or local governments, Tribal govern-*  
3 *ments, private entities, or academic institutions to improve,*  
4 *with respect to the Assessment, the use and integration of—*

5           (1) *advanced remote sensing and geospatial tech-*  
6 *nologies;*

7           (2) *statistical modeling and analysis; or*

8           (3) *any other technology the Secretary deter-*  
9 *mines will benefit the quality of information used in*  
10 *the Assessment.*

11       (f) *PLANNING.—The Coalition shall make information*  
12 *from this Assessment available to the Secretary concerned*  
13 *and State of California to integrate into the—*

14           (1) *State of California’s Wildfire and Forest Re-*  
15 *silience Action Plan;*

16           (2) *Forest Service’s 10-year Wildfire Crisis*  
17 *Strategy (or successor plan); and*

18           (3) *Department of the Interior’s Wildfire Risk*  
19 *Five-Year Monitoring, Maintenance, and Treatment*  
20 *Plan (or successor plan).*

21       (g) *RELATION TO THE NATIONAL ENVIRONMENTAL*  
22 *POLICY ACT OF 1969.—The development and submission of*  
23 *the Assessment under subsection (a) shall not be subject to*  
24 *the National Environmental Policy Act of 1969 (42 U.S.C.*  
25 *4321 et seq.).*

1 **SEC. 6. GIANT SEQUOIA EMERGENCY RESPONSE.**

2 (a) *EMERGENCY RESPONSE TO PROTECT GIANT SE-*  
3 *QUOIAS.*—

4 (1) *IN GENERAL.*—

5 (A) *EMERGENCY DETERMINATION.*—*Con-*  
6 *gress determines that—*

7 (i) *an emergency exists on covered pub-*  
8 *lic lands and covered National Forest Sys-*  
9 *tem lands that makes it necessary to carry*  
10 *out Protection Projects that take needed ac-*  
11 *tions to respond to the threat of wildfires,*  
12 *insects, and drought to giant sequoias; and*

13 (ii) *Protection Projects are necessary to*  
14 *control the immediate impacts of the emer-*  
15 *gency described in clause (i) and are needed*  
16 *to mitigate harm to life, property, or im-*  
17 *portant natural or cultural resources on*  
18 *covered public lands and covered National*  
19 *Forest System lands.*

20 (B) *APPLICATION.*—*The emergency deter-*  
21 *mination established under subparagraph (A)*  
22 *shall apply to all covered public lands and cov-*  
23 *ered National Forest System lands.*

24 (C) *EXPIRATION.*—*The emergency deter-*  
25 *mination established under subparagraph (A)*

1           *shall expire on the date that is 7 years after the*  
2           *date of the enactment of this Act.*

3           (2) *IMPLEMENTATION.*—*While the emergency de-*  
4           *termination established under paragraph (1) is in ef-*  
5           *fect, the following shall apply:*

6                   (A) *The Secretary concerned, acting through*  
7                   *a responsible official, shall carry out Protection*  
8                   *Projects on covered public lands and covered Na-*  
9                   *tional Forest System lands in accordance with*  
10                  *this section, all applicable land management*  
11                  *plans, and the laws (including regulations) ap-*  
12                  *plicable to the Secretary concerned.*

13                  (B) *A responsible official shall carry out*  
14                  *Protection Projects in accordance with the fol-*  
15                  *lowing, as applicable:*

16                          (i) *Section 220.4(b) of title 36, Code of*  
17                          *Federal Regulations (as in effect July 21,*  
18                          *2022), with respect to covered National For-*  
19                          *est System lands.*

20                          (ii) *Section 46.150 of title 43, Code of*  
21                          *Federal Regulations (as in effect October 12,*  
22                          *2022), with respect to covered public lands.*

23                          (iii) *Section 402.05 of title 50, Code of*  
24                          *Federal Regulations (as in effect July 21,*

1                   2022), with respect to covered National For-  
2                   est System lands and covered public lands.

3                   (iv) Section 800.12 of title 36, Code of  
4                   Federal Regulations (as in effect July 21,  
5                   2022), with respect to covered National For-  
6                   est System lands and covered public lands.

7                   (C) The rules established under subsections  
8                   (d) and (e) of section 40807 of the Infrastructure  
9                   Investment and Jobs Act (16 U.S.C. 6592c(d),  
10                  (e)) shall apply with respect to Protection  
11                  Projects by substituting “Protection Projects” for  
12                  “authorized emergency action under this section”  
13                  each place it appears in such subsections.

14                  (D) Protection Projects shall be subject to  
15                  the requirements of section 106 of the Healthy  
16                  Forests Restoration Act of 2003 (16 U.S.C.  
17                  6516).

18                  (3) PROTECTION PROJECTS.—The responsible of-  
19                  ficial shall carry out the following forest management  
20                  activities as Protection Projects under the emergency  
21                  determination under this section:

22                  (A) Conducting hazardous fuels manage-  
23                  ment, including mechanical thinning, mastica-  
24                  tion, and prescribed burning.

1           (B) *Removing hazard trees, dead trees, or*  
2           *dying trees, as determined by the responsible of-*  
3           *ficial.*

4           (C) *Removing trees to address overstocking*  
5           *or crowding in a forest stand, consistent with the*  
6           *appropriate basal area of the forest stand and*  
7           *the best available science, as determined by the*  
8           *responsible official.*

9           (D) *Activities to address insects, disease,*  
10          *invasive species, and vegetative encroachment of*  
11          *a giant sequoia grove.*

12          (E) *Any combination of activities described*  
13          *in this paragraph.*

14          (4) *REQUIREMENTS.—*

15           (A) *IN GENERAL.—Protection Projects car-*  
16           *ried out under paragraph (3) and reforestation*  
17           *and rehabilitation activities carried out under*  
18           *this Act that are described by subparagraph (C)*  
19           *are categorically excluded from the preparation*  
20           *of an environmental assessment or an environ-*  
21           *mental impact statement under section 102 of*  
22           *the National Environmental Policy Act of 1969*  
23           *(42 U.S.C. 4332).*

24           (B) *AVAILABILITY.—The Secretary con-*  
25           *cerned shall use the categorical exclusion estab-*

1            *lished under subparagraph (A) in accordance*  
2            *with this section.*

3            (C) *REQUIREMENTS.—A Protection Project*  
4            *or reforestation or rehabilitation activity is de-*

- 3 *ship opportunities to complete high-priority*
- 4 *reforestation or rehabilitation projects;*
- 5 (iii) *a timeline for addressing the*
- 6 *backlog of reforestation for giant sequoias in*
- 7 *the 10-year period after the agreement is*
- 8 *entered into under section 3; and*
- 9 (iv) *strategies to ensure genetic diver-*
- 10 *sity across giant sequoia groves; and*
- 11 (D) *includes program and policy rec-*
- 12 *ommendations needed to improve the efficiency*
- 13 *or effectiveness of the Strategy.*
- 14 (2) *ASSESSMENT.—The Secretary may incor-*
- 15 *porate the Strategy into the Assessment under section*
- 16 *5.*
- 17 (b) *PRIORITY REFORESTATION PROJECTS AMEND-*
- 18 *MENT.—Section 3(e)(4)(C)(i)(I) of the Forest and Range-*
- 19 *land Renewable Resources Planning Act of 1974 (16 U.S.C.*

7            (3) *MEMBERS.—The Secretary concerned may*  
8            *appoint no more than 10 individuals each to serve on*  
9            *a Strike Team comprised of—*

10            (A) *employees of the Department of the In-*

12            (B) *employees of the Forest Service;*

13            (C) *private contractors from any nonprofit*  
14            *organization, State government, Tribal Govern-*  
15            *ment, local government, academic institution, or*  
16            *private organization; and*

17            (D) *volunteers from any nonprofit organi-*  
18            *zation, State government, Tribal Government,*  
19            *local government, academic institution, or pri-*  
20            *vate organization.*

21 **SEC. 9. GIANT SEQUOIA COLLABORATIVE RESTORATION**

22 **GRANTS.**

23            (a) *IN GENERAL.—The Secretary, in consultation with*  
24            *the parties to the agreement under section 3, shall establish*  
25            *a program or expand an existing program to award grants*

1 *to eligible entities to advance, facilitate, or improve giant*  
2 *sequoia health and resiliency.*

3 (b) *ELIGIBLE ENTITY.*—*The Secretary may award*

8 (c) *PRIORITY.*—*In awarding grants under this section,*  
9 *the Secretary shall give priority to eligible entities that—*  
10 (1) *primarily, are likely to have the greatest im-*  
11 *act on giant sequoia health and resiliency; and*

12 (2) *secondarily—*  
13 (A) *are small businesses or Tribal entities,*  
14 *particularly in rural areas; and*

15 (B) *create or support jobs, particularly in*  
16 *rural areas.*

17 (d) *USE OF GRANT FUNDS.*—*Funds from grants*  
18 *awarded under this section shall be used to—*

19 (1) *create, expand, or develop markets for haz-*  
20 *ardous fuels removed under section 6, including mar-*  
21 *kets for biomass and biochar;*

22 (2) *facilitate hazardous fuel removal under sec-*  
23 *tion 6, including by reducing the cost of transporting*  
24 *hazardous fuels removed as part of a Protection*  
25 *Project;*

1           (3) *expand, enhance, develop, or create facilities*  
2           *or land that can store or process hazardous fuels re-*  
3           *moved under section 6;*

4           (4) *establish, develop, expand, enhance, or im-*  
5           *prove nursery capacity or infrastructure necessary to*  
6           *facilitate the Strategy established under section 7; or*

7           (5) *support Tribal management and conserva-*  
8           *tion of giant sequoias, including funding for Tribal*  
9           *historic preservation officers.*

10 **SEC. 10. GIANT SEQUOIA INSECT MONITORING AND TECH-**  
11 **NOLOGY.**

12           (a) *IN GENERAL.*—*Not later than 1 year after the date*  
13 *of the enactment of this Act, the Secretary concerned shall—*

14           (1) *develop and implement a strategy for moni-*  
15 *toring insects in giant sequoia groves with a high-risk*  
16 *or previous history of insect infestations; and*

1           (2) *an update on the effectiveness of the moni-*

3           *festations in giant sequoia groves; and*

4           (3) *program and policy recommendations to fur-*  
5           *ther address—*

6                   (A) *research gaps regarding giant sequoia*  
7                   *resiliency to insects; and*

8                   (B) *opportunities to improve the resiliency*  
9                   *of giant sequoias to insects.*

10 **SEC. 11. STEWARDSHIP CONTRACTING FOR GIANT SE-**  
11 **QUOIAS.**

9       **(c) STEWARDSHIP CONTRACTING IN CERTAIN NA-**  
10       **TIONAL PARKS.**—*Stewardship contracting projects occur-*  
11       *ring in Kings Canyon National Park, Sequoia National*  
12       *Park, and Yosemite National Park shall be carried out in*  
13       *accordance with the laws (including regulations) applicable*  
14       *to the National Park Service, including section 100753 of*

2 *comprehensive program to assist and promote philanthropic*  
3 *programs of support that benefit—*

4           “(1) *primarily, the management and conserva-*  
5 *tion of giant sequoias on covered public lands and*  
6 *covered National Forest System lands to promote re-*  
7 *siliency to wildfires, insects, and drought; and*

8           “(2) *secondarily, the reforestation of giant se-*  
9 *quoias on covered public lands and covered National*  
10 *Forest System lands impacted by wildfire.*

11       “(b) *GIANT SEQUOIA EMERGENCY PROTECTION*  
12 *FUND.—*

13           “(1) *IN GENERAL.—The National Park Founda-*  
14 *tion, in coordination with the National Forest Foun-*  
15 *dation and the Foundation for America’s Public*  
16 *Lands, shall establish a joint special account to be*  
17 *known as the Giant Sequoia Emergency Protection*  
18 *Fund (referred to in this section as ‘the Fund’), to be*  
19 *administered in support of the program established*  
20 *under subsection (a).*

21           “(2) *FUNDS FOR GIANT SEQUOIA EMERGENCY*  
22 *PROTECTION.—The Fund shall consist of any gifts,*  
23 *devises, or bequests that are provided to the National*  
24 *Park Foundation, National Forest Foundation, or*

1       *Foundation for America’s Public Lands for the pur-*  
2       *pose described in paragraph (1).*

3               “(3) *USE OF FUNDS.—Funds shall be available*  
4       *to the National Park Foundation, National Forest*  
5       *Foundation, and Foundation for America’s Public*  
6       *Lands without further appropriation, subject to the*  
7       *provisions in paragraph (4), for projects and activi-*  
8       *ties approved by the Director of the National Park*  
9       *Service, Chief of the Forest Service, or Director of the*  
10       *Bureau of Land Management as appropriate, or their*

12               “(A) *primarily, support the management*

1        *ment and conservation of giant sequoias including*

3        “(c) *SUMMARY.—Beginning 1 year after the date of*  
4        *the enactment of this Act, the National Park Foundation,*  
5        *National Forest Foundation, and Foundation for America’s*  
6        *Public Lands shall include with their annual reports a*  
7        *summary of the status of the program and Fund created*  
8        *under this section that includes—*

9                “(1) *a statement of the amounts deposited in the*  
10        *Fund during the fiscal year;*

11                “(2) *the amount of the balance remaining in the*  
12        *Fund at the end of the fiscal year; and*

13                “(3) *a description of the program and projects*  
14        *funded during the fiscal year.*

15        “(d) *DEFINITIONS.—In this section, the terms ‘covered*  
16        *public lands’ and ‘covered National Forest System lands’*  
17        *have the meaning given such terms in section 2 of the Save*  
18        *Our Sequoias Act.*

19        “(e) *TERMINATION OF EFFECTIVENESS.—The author-*  
20        *ity provided by this section shall terminate 7 years after*  
21        *the date of enactment of the Save Our Sequoias Act.”.*
