To amend the Water Resources Research Act of 1984 to reauthorize the water resources research and technology institutes program, and for other purposes.

A BILL

To amend the Water Resources Research Act of 1984 to reauthorize the water resources research and technology institutes program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Advancing Water Re-
5 search and Collaboration Act of 2025” or the “AWRC Act
6 of 2025”.

1 **SEC. 2. CONGRESSIONAL DECLARATION OF PURPOSE.**

2 Section 103(4) of the Water Resources Research Act
3 of 1984 (42 U.S.C. 10302(4)) is amended by inserting “,
4 including the growing artificial intelligence industry,”
5 after “private industry”.

6 **SEC. 3. WATER RESOURCES RESEARCH AND TECHNOLOGY**
7 **INSTITUTES.**

8 Section 104 of the Water Resources Research Act of
9 1984 (42 U.S.C. 10303) is amended—

10 (1) in subsection (f)—

11 (A) in paragraph (2), by striking “sub-
12 section 104(g) of this Act” and inserting “sub-
13 section (g)”;

14 (B) by striking the subsection designation
15 and all that follows through “Any sums” in
16 paragraph (2) and inserting the following:

17 “(f) GENERAL AUTHORIZATION OF APPROPRIA-
18 TIONS.—

19 “(1) IN GENERAL.—Except as provided in para-
20 graph (2), there is authorized to be appropriated to
21 carry out this section \$16,000,000 for each of fiscal
22 years 2026 through 2029.

23 “(2) FAILURE TO OBLIGATE.—Any amounts”;
24 and

25 (2) in subsection (g)—

1 (A) in paragraph (2), by striking “(2) Re-
2 search funds” and inserting the following:

3 “(4) COMPETITIVE GRANTS.—Research funds”;

4 (B) in paragraph (1)—

5 (i) in the third sentence, by striking
6 “Funds made” and inserting the following:

7 “(3) AVAILABILITY OF FUNDS.—Funds made”;

8 and

9 (ii) by striking “by institutes which
10 focuses” in the first sentence and all that
11 follows through “Such funds when appro-
12 priated” in the second sentence and insert-
13 ing the following: “by institutes with re-
14 spect to any of the following:

15 “(A) Research that focuses on water prob-
16 lems and issues of a regional or interstate na-
17 ture beyond those of concern only to a single
18 State.

19 “(B) Research that relates to specific pro-
20 gram priorities identified jointly by the Sec-
21 retary and the institutes.

22 “(C) Research that relates to water prob-
23 lems identified by Congress as being of an
24 interstate nature.

1 “(2) FEDERAL COST-SHARE.—Funds made
2 available under this subsection”; and

3 (C) by striking the subsection designation
4 and all that follows through “only” in the first
5 sentence of paragraph (1) and inserting the fol-
6 lowing:

7 “(g) ADDITIONAL FUNDS FOR RESEARCH FOCUSED
8 ON WATER PROBLEMS OF INTERSTATE NATURE.—

9 “(1) IN GENERAL.—Of the amounts authorized
10 under subsection (f)(1) for each of fiscal years 2026
11 through 2029, not more than 20 percent is author-
12 ized to be used”.
