I own and operate Cattle For the Kingdom where I not only provide grassfed beef to local ministries, but also manage herds for others. Additionally, I am the executor of my paternal family's farming operation as well as the senior pastor of Unity Temple Family Church and its inherent components including Kingdom Community Development Services and Rural Impact Food Pantry, which has participated in F2F since the beginning to serve well over a million people in rural Oklahoma. I am actively engaged in USDA, RD, FSA, NRCS, OACD, WCD; specifically EQUIP, Community Facilities, Conservation Stewardship Program and more. While I currently serve on Oklahoma's USDA NRCS State Technical Committee, I also partner with NRCS to host community outreach meetings four times a year, Langston University, OSU Agricultural Extension and the Noble Research Institute. I also partner with IRUSA, Convoy of Hope, Northstar Bridge, Joshua House Pantry and Cherokee Cultural Outreach.
