MANAGER'S AMENDMENT
Offered by Mr. Quigley of Illinois

In the REPORT:

On page 30, in the first full paragraph strike "180 days" and insert "90 days".

On page 62, before the heading "Election Security Grants", insert the following:

" *Survivor Safety in Voting.*—The Committee recognizes that survivors of intimate-partner violence and sexual assault may choose to not register to vote because their personally identifiable information may be released or accessed in voter registration databases. Several states have established voter privacy programs that enable survivors of domestic violence, stalking, sexual assault, trafficking, and dating violence to keep their personally identifiable information, such as a home address, confidential. The Committee directs EAC to publish guidance for states on how to advance the privacy and safety of survivors when registering to vote or casting a ballot, including best practices for establishing voter privacy programs. Such guidance shall be written in consultation with organizations with expertise in intimate-partner violence and sexual assault and technology safety, including culturally specific programs. "

“ 6 GHz.—The Committee continues to hear concerns about the potential for harmful interference to important public safety and critical infrastructure communications systems within the 6 GHz band. Within 90 days of enactment of this Act, the FCC is directed to brief the Committee on the Commission’s engineering analysis leading to its decision concerning the use of the 6 GHz band and detail how the FCC will ensure that incumbents are properly protected from harmful interference.”

On page 102, after the last paragraph insert the following:

“ *Division of Economic and Risk Analysis (DERA).*—The Committee is aware of the significant volume of proposals currently being put forth by the SEC and supports the cost benefit analysis process. In furtherance of this process, the Committee supports DERA and its important work analyzing the impact of the Commission’s proposed regulations and expects DERA to be allocated sufficient funding to ensure that the economic impact of proposed rules is fully understood.”

On page 105, before the paragraph titled “*Center for Verification and Evaluation (CVE)*”, insert the following:

“ The Committee supports SBA’s ongoing efforts to improve small businesses’ awareness of SBA resources. The Committee recommends that SBA and its resource partners provide information outlining federal tax benefits and resources related to child care available to small business employers and employees. The Committee believes greater awareness and understanding of available resources would help drive their increased utilization. ”

5 ture as a service except infrastructure as a service deter-
6 mined by the Government to take reasonable measures
7 to—

8 (1) not store or transmit images which depict
9 known violations of sections 2251, 2251A, 2252,
10 2252A, 2252B or 2260 of title 18, United States
11 Code, with respect to child pornography; and

12 (2) comply with the reporting requirements
13 under section 2258A(a) of such title for such viola-
14 tions.

15 (b) The limitation in subsection (a) shall not apply
16 to such services used for bona fide law enforcement ac-
17 tions.

4 (a) IN GENERAL.—Section 6050W(e) of the Internal
5 Revenue Code of 1986 is amended to read as follows:

6 “(e) EXCEPTION FOR DE MINIMIS PAYMENTS BY
7 THIRD PARTY SETTLEMENT ORGANIZATIONS.—A third
8 party settlement organization shall be required to report
9 any information under subsection (a) with respect to third
10 party network transactions of any participating payee only
11 if—

12 “(1) the amount which would otherwise be re-
13 ported under subsection (a)(2) with respect to such
14 transactions exceeds \$20,000, and

15 “(2) the aggregate number of such transactions
16 exceeds 200.”.

10 SEC. 811. No funds available for obligation or ex-

12 any authority shall be expended for any abortion except
13 where the life of the mother would be endangered if the
14 fetus were carried to term or where the pregnancy is the
15 result of an act of rape or incest.

7 ministration; or

8 (2) the 12-month all items index percentage change,
9 before seasonal adjustment, in the Consumer Price Index,
10 as measured by the Bureau of Labor Statistics.

11 (b) Subsection (a) shall not apply to any regulation
12 regarding national security.

13 (c) This section shall apply through fiscal year 2023
14 or until—

17 tion Administration, is at or below \$2.47 per gallon;
