MANAGERS' AMENDMENT - DEPARTMENT OF
STATE, FOREIGN OPERATIONS, AND RELATED

AMENDMENT TO THE BILL

On page 260, between lines 2 and 3, insert the following new subsection:

"(c) LIMITATION.—Notwithstanding any other provision of law, none of the funds made available by this Act may be made available to the Wuhan Institute of Virology located in the City of Wuhan in the People's Republic of China.".

AMENDMENTS TO THE REPORT

On page 12 of the Report, after the paragraph headed, "Commercial Diplomacy" and before the paragraph headed "Conventional Arms Transfer Policy oversight", insert the following new paragraph:

"Congressional oversight.—A core responsibility of the Committees on Appropriations is to conduct oversight of the funds appropriated and made available for assistance for countries. This includes being able to visit the coun-

tries and communities where such assistance is being delivered. The Committee urges the Secretary of State to work with governments receiving assistance from funds appropriated by this Act to ensure Members of Congress are granted the necessary travel documents and approvals to exercise oversight of such assistance.".

On page 15 of the Report, at the end of the paragraph headed "Timely Processing of Passports and Visas", insert the following new sentence:

"The Committee further directs the Secretary to appropriately weigh the impact of increased passport and visa fees on applicants and petitioners prior to making any such increases.".

On page 36 of the Report, on the fifth line of the first paragraph strike "\$202,368,000" and insert "\$205,840,000" and on the seventh line of the paragraph strike "\$107,632,000" and insert "\$104,160,000".

On page 83 of the Report, before the heading "Section 7016 (Documents, Report Posting, Records Management, and Related Cybersecurity Protections)", insert the following new paragraph:

"Individuals Detained at United States Naval Station, Guantanamo Bay, Cuba.—Not later than 5 days after the conclusion of an agreement with a country, including a state with a compact of free association with the United States, to receive by transfer or release individuals detained at the United States Naval Station, Guantanamo Bay, Cuba, the Secretary of State shall notify the Committees on Appropriations in writing of the terms of the agreement, including whether funds appropriated by this Act or prior Acts making appropriations for the Department of State, foreign operations, and related programs will be made available for assistance for such country pursuant to such agreement.".

On page 96 of the Report, before the heading "Jordan", insert the following new paragraph:

"The Committee continues to support the People-to-People Partnership for Peace Fund Advisory Board created under the Nita M. Lowey Middle East Partnership for Peace Act of 2020. Advisory Board members play an integral role in making recommendations to the USAID Administrator regarding the types of projects that should be considered for funding through the Fund. The Committee directs USAID to provide the Advisory Board members the appropriate information to carry out their responsibilities, other than information that is considered procurement-sensitive. This information shall include, but not be limited to: grantee recipient names and awards once available; progress reports on the status of current

grantees; total number of applications; and geographic and demographic information of recipients. The Committee further directs USAID to continue consulting with the Committees on Appropriations on implementation of the Nita M. Lowey Middle East Partnership for Peace Act of 2020.".

On page 125 of the Report in the paragraph headed "Resiliency of North American supply chains", strike the last sentence and insert in lieu thereof the following:

"Further, the report directed that the strategy shall define steps the United States is taking, and plans to take, to work with Mexico and Canada to build resilient and trusted North American supply chains, including on critical and emerging technologies, such as semiconductors and healthcare industry products. The Committee directs the State Department to expeditiously submit such report, and to provide an update to such committees on the implementation of the strategy not later than September 30, 2023."

On page 128 of the Report, before the heading "Section 7047 (Countering Russian Influence and Aggression)", insert the following new paragraph:

"The Committee supports additional funds being made available to collect, analyze, and preserve evidence and in-

formation related to war crimes and other atrocities committed during the invasion of Ukraine for use in prosecuting those responsible for such crimes.".









At the end of the bill (before the short title), insert the following:

SEC. _____. None of the funds made available by this Act may be used to fund any work to be performed by EcoHealth Alliance, Inc. in China on research supported by the government of China unless the Secretary of State determines that a waiver to such prohibition is in the national security interests of the United States and, not later than 14 days after granting such a waiver, submits to the appropriate congressional committees a detailed justification for the waiver, including—

- (1) an identification of the Department of State entity obligating or expending the funds;
- (2) an identification of the amount of such funds;
- (3) an identification of the intended purpose of such funds;
- (4) an identification of the recipient or prospective recipient of such funds (including any third-party entity recipient, as applicable);
- (5) an explanation for how the waiver is in the national security interests of the United States; and
- (6) any other information the Secretary determines appropriate.

UKRAINE OVERSIGHT

SEC. . Ukraine Oversight

- (a) Oversight of Direct Financial Support to the Government of Ukraine.—
 - (1) Funds appropriated by this Act and made available to the Government of Ukraine as a cash transfer shall be subject to a memorandum of understanding that describes how the funds proposed to be made available will be used and includes appropriate safeguards for transparency and accountability: *Provided*, That such assistance shall be maintained in a separate, auditable account and may not be comingled with any other funds: *Provided further*, That at least 15 days prior to the initial obligation of such funds, the Secretary of State or the Administrator of the United States Agency for International Development, as appropriate, shall submit to the appropriate congressional committees a report detailing procedures and processes to ensure such funds are used by the Government of Ukraine in the manner agreed to by such Government, including details on the memorandum of understanding and appropriate safeguards for transparency and accountability required by this paragraph, if applicable: *Provided further*, That such report shall be updated every six months following the submission of the first report and shall be submitted until funds made available for such direct financial support are expended.
 - (2) The Secretary of State or the Administrator of the United States Agency for International Development, as appropriate, shall report to the appropriate congressional committees on the uses of any funds appropriated by this Act and provided for direct financial support to the Government of Ukraine and the results achieved, not later than 90 days after the date of enactment of this Act and every 90 days thereafter until September 30, 2025: *Provided*, That such report shall also include the metrics established to measure such results.
 - (3) Funds appropriated by this Act and made available for direct financial support for the Government of Ukraine shall be subject to the regular notification procedures of the Committees on Appropriations.
- (b) Notification Requirements.—Notifications required for assistance for Ukraine pursuant to the requirements of this Act or title VI of division N of Public Law 117-103 or title V of Public Law 117-128 shall include the requirements enumerated under this section in the report accompanying this Act.
- (c) Inspectors General.—The Inspectors General of the Department of State and United States Agency for International Development shall carry out reviews of the activities of their respective agencies to execute any funds appropriated by this Act for assistance for Ukraine and funds appropriated in title VI of division N of Public Law 117-103 and title V Public Law 117-128: *Provided*, That the Inspectors General shall coordinate with the

Inspector Generals of the Department of Defense and other relevant Federal agencies in conducting such oversight: *Provided further*, that the Inspectors General shall provide to the appropriate congressional committees an initial written report not later than 120 days after the date of enactment of this Act.


(d) Reports.—

- (1) The Secretary of State, in coordination with the USAID Administrator, shall submit a report, not later than 45 days after enactment of this Act and every 90 days thereafter until September 30, 2024, to the appropriate congressional committees on funding and other in-kind donations, commodities, and other articles provided to Ukraine by other donors after February 24, 2022: *Provided*, That such report shall include funding disaggregated by donor, type of assistance, including funds made available for budget support, and shall be displayed in United States Dollars.
- (2) The Secretary of State, in coordination with the USAID Administrator, shall submit a report, not later than 45 days after enactment and every 90 days thereafter until September 30, 2024 on all assistance provided pursuant to this Act or title VI of division N of Public Law 117-103 or title V of Public Law 117-128 to Ukraine, including a breakdown of programs by funding amount, implementing partner, as appropriate, geographic region, and a summary of assistance provided

In the report at the appropriate place, insert the following:

"Section _____. (Ukraine Oversight)

Subsection (b) requires notifications for assistance for Ukraine to include for each program notified: (1) total funding appropriated for such program, by account and fiscal year; (2) funding that remains unobligated for such programs; (3) funding that is obligated but unexpended for such program; and (4) funding committed, but not yet notified for such program.
