Congestion pricing impact study.— The Committee is concerned about the Metropolitan Transportation Authority's (MTA) Central Business District Tolling Program (CBDTP) and its outsized financial impact on working-class suburban commuters who rely on personal vehicles, especially in regions where safe, affordable, and reliable public transit is unavailable or insufficient. The Committee believes that Federal transportation policy should not endorse coercive tolling regimes that disproportionately burden one group of commuters, such as working-class motorists, in order to subsidize others, such as transit riders. The Committee further notes that numerous public reports of longstanding operational inefficiencies, fare evasion, and fiscal mismanagement within the MTA have contributed to its financial instability and increased reliance on mechanisms like congestion pricing to close budget gaps, rather than implementing needed internal reforms.

Accordingly, the Committee directs the Secretary, in coordination with the Federal Highway Administration and the Federal Transit Administration, to conduct a comprehensive study of the CBDTP's financial impact on suburban commuters who travel by motor vehicle. The study shall be conducted utilizing existing departmental resources. The study should include a detailed breakdown of the projected annual toll burden on commuters by ZIP code of residence; an assessment of the availability, affordability, and safety of alternative transit options in those ZIP codes; and an analysis of the MTA's financial management practices and operating expenditures over the past 10 years. The study shall also include specific recommendations for how the MTA can improve operational efficiency and reduce costs in order to meet its capital and operating needs without relying on congestion-based tolling revenues. The Committee directs the Department to submit the final report to the House and Senate Committees on Appropriations no later than one year after enactment of this Act.

(a) Program and Regulatory Efficiency Reviews.

None of the funds appropriated or otherwise made available by this Act to the Department of Transportation, the Department of Housing and Urban Development, the Federal Transit Administration, the Federal Highway Administration, or any related agency may be obligated or expended unless the Secretary—

- Conducts annual program and operational performance reviews using outcome-based metrics consistent with the Government Performance and Results Modernization Act of 2010 (Public Law 111-352);
- (2) Completes a comprehensive review of agency rules, internal policies, and administrative requirements to identify outdated, duplicative, or inefficient provisions, and submits a Regulatory Modernization Report to the Committees on Appropriations within 18 months of enactment.
- (3) Identifies cost savings, administrative streamlining opportunities, and overlapping functions;
- (4) Adopts a framework to implement technological solutions for project oversight, milestone verification, and transparent reporting of disbursements; and
- (5) Submits a consolidated summary of findings and planned improvements to the Committees on Appropriations within 240 days of enactment.
- (b) Contracting and Procurement Standards.

None of the funds made available by this Act may be used to enter into a new contract, grant, or cooperative agreement exceeding \$5,000,000 unless –

(1) The award is made through full and open competition, except where urgent financial stability, national security, or public interest functions are certified in writing to the Committees on Appropriations;

(2) The contract, grant, or cooperative agreement includes enforceable provisions requiring(i) project delivery on budget and on schedule; and (ii) the delineation of specific performance objectives and milestones with timelines for meeting such objectives and milestones;

(3) The awarding agency adopts a framework to implement a technology-based or otherwise automated system to (i) verify and track awardee progress against agreement objectives, milestones, and timelines; (ii) make continuous disbursements contingent upon verified completion of agreement objectives, milestones, and timelines; and (iii) securely record and retain verification data and supporting documentation to ensure a transparent audit trail of each disbursement;

(4) The agreement includes appropriate financial penalties, including liquidated damages, for unjustified cost overruns or schedule delays; and

(5) For contracts or agreements exceeding \$10,000,000, the agency must submit a Contract Performance Summary to the Committees within 90 days of award.

(c) Quarterly Oversight Reporting

(3) Performance status of high-value contracts and grants, including details on performance objectives, the completion of milestones, and related timelines in

accordance with subsection (b)(2)(ii) and (b)(3), accompanied by verification records preserved by a technology-based or otherwise automated system;

- (4) Identified cost savings and reinvestment proposals; and
- (5) Status of updated performance metrics as required under section (d).

(d) Development and Submission of Updated Performance Metrics

None of the funds made available by this Act may be obligated or expended unless each agency covered under this section –

- (1) Develops or updates performance metrics aligned with the findings of subsection (a)(1);
- (2) Ensures all performance metrics are consistent with GPRMA standards and relevant to strategic goals (e.g., procurement timeliness, fraud prevention, IT modernization outcomes), and incorporates provisions for the secure recording and retention of verification data used to confirm the achievement of a contract, grant, or cooperative agreement, ensuring traceability and a transparent audit trail of each disbursement;

- (4) Provides a justification for each measure explaining its role in improving agency effectiveness, cost control, or public service.

TRANSPORTATION-HOMELAND BORDER RIVER ROAD PROGRAM AMENDMENT

TRANSPORTATION-HOMELAND BORDER RIVER ROAD PROGRAM SEC. ____.

(a) Use of Funds.— The Secretary of Transportation, in coordination with the Secretary of Homeland Security and the Commissioner of the International Boundary and Water Commission, shall use amounts made available under this Act to carry out rural road infrastructure improvements in U.S. border regions. The goals of this effort are to promote safe and reliable access to international boundary waterways for border security, public access, and vegetation management.

(b) Funding Source.— The activities authorized under this section shall be carried out using amounts otherwise appropriated under this Act to the Department of Transportation and the Department of Homeland Security.

(c) Eligible Activities.— Funds made available for purposes of this section may be used for:

- (1) The construction, expansion, or maintenance of river-adjacent roads and right-of-way infrastructure near international boundary waterways;
- (2) Vegetation management and biomass reduction to improve visibility and control invasive species such as, but not limited to, Carrizo cane.

(d) Geographic Eligibility.— Activities under this section shall be limited to areas located in counties or jurisdictions that share an international river boundary with Mexico.

(e) Cost-Sharing.— Projects located in designated underserved, Tribal, or colonia zones shall be eligible for up to 100 percent federal support.

(f) Interagency Coordination.— The Secretary of Transportation shall coordinate with the Department of Homeland Security, the International Boundary and Water Commission, and relevant State and Tribal agencies to ensure strategic alignment with border security and public access goals.

(g) Performance Reporting.— The Secretaries of Transportation and Homeland Security shall submit a joint report to the Committees on Appropriations not later than 180 days after enactment of this Act, and annually thereafter, detailing:

(1) Miles of road or bridge infrastructure improved or constructed;

- (2) Acreage of vegetation cleared and visibility restored;
- (3) Any operational or ecological benefits resulting from these activities.

UNMANNED AIRCRAFT ACTIVITY AT THE U.S.-MEXICO BORDER

U.S. Mexico Border Unmanned Aircraft Exclusion Zone. – The Committee recognizes concerns with cartels utilizing unmanned aircraft systems (UAS) along the U.S.-Mexico border to monitor border patrol and troop activities to allow cartels to smuggle people and illicit items across the border. The Committee further recognizes the increased use of weaponized UAS to launch attacks on border patrol agents and troops. As such, the Committee encourages the Federal Aviation Administration (FAA), in coordination with the Department of Homeland Security and U.S. Customs Border Protection (CBP), to establish an exclusion zone along the entire U.S.-Mexico border. Further the Committee encourages exceptions to the exclusion zone be considered for UAS operated by federal or state government, or law enforcement for emergency responses and border security purposes, and for farmers, ranchers, and other individuals and entities licensed or approved by the FAA.

These restrictions, enforced through Temporary Flight Restrictions (TFRs) under 14 CFR §99.7 in consultation with law enforcement and security agencies, serve as critical tools to ensure public safety and national security. In anticipation of upcoming large-scale international events hosted in the United States, such as the FIFA World Cup and 2028 Olympics as well as the 250th anniversary of our nation, the Committee urges the FAA to coordinate closely with federal, state, and local partners to ensure similar protections are extended to associated venues and activities, including FIFA Fan Fests and other officially sanctioned events that may not fall within the current scope of stadium-based TFRs but still draw significant crowds and present heightened security concerns. The Committee directs the FAA to evaluate the need for expanded TFR coverage or alternative enforcement mechanisms during mega events and to prioritize UAS safety certifications, authorizations, and enforcement efforts in coordination with event security planning. This includes proactively addressing risks from unauthorized drone operations and ensuring that public safety agencies have the necessary guidance and tools to detect, deter, and respond to such threats."
