

AMENDMENT TO H.R. 1735**OFFERED BY MR. WILSON OF SOUTH CAROLINA**

At the end of title XXVIII, add the following new section:

1 **SEC. 28___ . AMENDMENTS TO THE NATIONAL HISTORIC**
2 **PRESERVATION ACT.**

3 (a) CRITERIA AND REGULATIONS RELATING TO NA-
4 TIONAL REGISTER, NATIONAL HISTORIC LANDMARKS,
5 AND WORLD HERITAGE LIST.—Section 302103 of title
6 54, United States Code, is amended—

7 (1) in subparagraph (E), by striking “and”;

8 (2) in subparagraph (F), by striking the period
9 and inserting “; and”; and

10 (3) by adding at the end the following:

11 “(G) notifying the Committee on Natural
12 Resources of the United States House of Rep-
13 resentatives and the Committee on Energy and
14 Natural Resources of the Senate if the property
15 is owned by the Federal Government when the
16 property is being considered for inclusion on the
17 National Register, for designation as a National
18 Historic Landmark, or for nomination to the
19 World Heritage List.”.

1 (b) REGULATIONS.—Section 302107 of title 54,
2 United States Code, is amended—

3 (1) in paragraph (2), by striking “and”;

4 (2) in paragraph (3), by striking the period and
5 inserting “; and”; and

6 (3) by adding at the end the following:

7 “(4) to allow for expedited removal of Federal
8 property listed on the National Register of Historic
9 Places if the managing agency of that Federal prop-
10 erty submits to the Secretary a written request to
11 remove the Federal property from the National Reg-
12 ister of Historic Places for reasons of national secu-
13 rity, such as any impact the inclusion or designation
14 would have on use of the property for military train-
15 ing or readiness purposes.”.

16 (c) OBJECTION TO INCLUSION OR DESIGNATION FOR
17 REASONS OF NATIONAL SECURITY.—Chapter 3021 of
18 title 54, United States Code, is amended by adding at the
19 end the following:

20 **“§ 302109. Objection to inclusion or designation for**
21 **reasons of national security**

22 “If the head of the agency managing any Federal
23 property objects to such inclusion or designation for rea-
24 sons of national security, such as any impact the inclusion
25 or designation would have on use of the property for mili-

1 tary training or readiness purposes, that Federal property
2 shall be neither included on the National Register nor des-
3 igned as a National Historic Landmark until the objec-
4 tion is withdrawn”.

5 (d) CONFORMING AMENDMENT.—The table of sec-
6 tions at the beginning of chapter 3021 of title 54, United
7 States Code, is amended by adding at the end the fol-
8 lowing new item:

“302109. Objection to inclusion or designation for reasons of national security.”.
