At the appropriate place in title VIII, insert the following new section:

1	SEC. 8 TRANSFER OR POSSESSION OF DEFENSE ITEMS

3	(a) Transfer and Possession Exceptions.—Sec-
4	tion 922(o)(2) of title 18, United States Code, is amend-
5	ed
6	(1) in subparagraph (A), by striking "or by"
7	and inserting ", by, or under the authority of";
8	(2) by striking "or" at the end of subparagraph
9	(A);
10	(3) by striking the period at the end of sub-
11	paragraph (B) and inserting a semicolon; and
12	(4) by inserting after subparagraph (B) the fol-
13	lowing new subparagraphs:
14	"(C) a transfer to, or possession by, a licensed
15	manufacturer or licensed importer (if, with respect
16	to a transfer, such transfer has been approved by
17	the Attorney General in accordance with law) for
18	purposes of—

1	"(i) joint production of a weapon, or inte-
2	gration or incorporation into another article or
3	device;
4	"(ii) calibration, testing, or research and
5	development;
6	"(iii) permanent or temporary export, or
7	temporary import, otherwise in accordance with
8	law; or
9	"(iv) training of Federal, State, local, or
10	foreign government personnel;
11	"(D) a transfer to, or possession by, a licensee
12	for the purpose of repair and return of the same to
13	a lawful possessor; or
14	"(E) notwithstanding subsection (g)(5)(B), pos-
15	session by foreign government personnel for official
16	training purposes under the direct and continuous
17	supervision of an authorized Federal, State, or local
18	government official, or a licensee as described in
19	subparagraph (C), provided that, upon completion of
20	the training, such foreign government personnel
21	shall relinquish possession of the same to such offi-
22	cial or licensee.".
23	(b) Importation Requirements.—Section 925(d)
24	of such title is amended—
25	(1) in paragraph (3)—

1	(A) by inserting "except as provided in
2	paragraph (5)," before "is of"; and
3	(B) by striking "or" at the end;
4	(2) in paragraph (4), by striking the period at
5	the end and inserting "; or"; and
6	(3) by inserting after paragraph (4) the fol-
7	lowing new paragraph:
8	"(5) is being imported or brought in by a li-
9	censed manufacturer or licensed importer in con-
10	formity with, and solely for a purpose described in
11	subparagraph (A), (C), (D), or (E) of section
12	922(o)(2).".
13	(c) EFFECTIVE DATE.—This section and the amend-
14	ments made by this section shall take effect 30 days after
15	the date of the enactment of this Act.
