Strike titles I, II, IV, and VI.

Strike sections 301 and 302.

Page 12, strike line 21 and all that follows through page 13, line 2, and insert the following:

- (b) CONTENTS.—The report submitted to the Congress under subsection (a) shall— 3 (1) evaluate whether the stress tests are suffi-4 ciently robust and promote preparedness; and 5 (2) consider whether the stress tests adequately 6 identify salient risks to— (A) the safety and soundness of the 8 nonbank financial institutions and bank holding companies subjected to stress tests; and 9 10 (B) the stability of the United States fi-11 nancial system.
  - Page 38, beginning on line 11, strike "Not later than 60 days after the date of enactment of this paragraph, the" and insert "The".

Page 38, beginning on line 16, strike ", and shall complete such review not later than 240 days after the date of enactment of this paragraph".

Page 38, line 24, after "institutions" insert "(including different types of financial institutions, such as rural insured depository institutions, minority depository institutions, and community development financial institutions)".

Page 39, line 9, after "banks" insert "and financial institutions, the Board of Governors, and other relevant regulators".

Page 39, line 13, insert before the semicolon the following: "and ensuring consistent access to the discount window across the Federal Reserve System".

Page 41, beginning on line 23, strike "Comptroller General of the United States and the Inspector General of the Board of Governors of the Federal Reserve System and the Bureau of Consumer Financial Protection" and insert "Comptroller of the Currency and Federal Deposit Insurance Corporation".

Page 42, beginning on line 4, strike "Comptroller General and Inspector General" and insert "Comptroller of the Currency and Federal Deposit Insurance Corporation".

Page 42, line 9, strike "testify before the Committee on Financial Services of the House of Representatives and the Committee on Banking, Housing, and Urban Affairs of the Senate" and insert ", at the next semi-annual appearance before Congress described under section 2B, include in such appearance testimony".

Page 42, line 24, insert before the period the following: "and a progress report on the implementation of the remediation plan required under subparagraph (D)".

Page 43, after line 12, insert the following:
