Page 113, line 10, strike “this part” and insert “this subtitle and sections 22101 and 22102”.

Page 141, line 19, insert “health care,” before “public health”.

Page 146, lines 18 and 19, strike “et seq.”.

Page 146, line 19, strike “and for the purposes of” and insert “, including”.

Page 146, line 21, before the period, insert “, except that for the purposes of this section, outlying areas as defined in section 3 of such Act (29 U.S.C. 3102) shall be considered eligible to receive funds under this section”.

Page 154, line 2, insert “under” after “employees”.

Page 195, line 12, strike “parents’” and insert “parent(s)’”.

Page 198, strike lines 4 through 16, and insert the following:

1 (2) ADMINISTRATION.—

2 (A) FISCAL YEARS 2022 THROUGH 2024.—

3 In addition to amounts otherwise available,  
4 there is appropriated to the Department of  
5 Health and Human Services, out of any money  
6 in the Treasury not otherwise appropriated,  
7 \$130,000,000 for each of fiscal years 2022,  
8 2023, and 2024, to carry out subsection (k).  
9 Amounts appropriated by the preceding sen-  
10 tence shall be available for one fiscal year.

11 (B) FISCAL YEARS 2025 THROUGH 2027.—

12 From the amounts appropriated under sub-  
13 section (a), the Secretary shall reserve, to carry  
14 out subsection (k), up to 1 percent of such  
15 amounts for each of fiscal years 2025, 2026,  
16 and 2027, which shall be in addition to  
17 amounts otherwise available for this purpose.  
18 Amounts appropriated by the preceding sen-  
19 tence shall be available for one fiscal year.

Page 213, strike lines 12 through 15, and insert the  
following:

20 (IV) \$9,600,000,000 for each of  
21 the fiscal years 2022 through 2027 to  
22 carry out the program of grants to lo-  
23 calities in subsection (i).

Page 215, line 11, strike “this clause” and insert “clause (ii)(II)”.

Page 219, beginning on line 19, strike “section 08\_\_ (b)” and insert “ subsection (h)(2)”.

Page 230, line 18, strike “eligible children” and insert “children in families with income that does not exceed 200 percent of the Federal poverty level”.

Beginning on page 230, strike line 22 and all that follows through line 5 on page 231 (and make such technical and conforming changes as may be appropriate).

Page 250, line 11, strike “and” at the end.

Page 250, after line 11, insert the following (and make such technical and conforming changes as may be appropriate):

- 1 (vi) at a minimum, provide a living
- 2 wage for all staff of such providers; and

Page 257, line 6, strike “, as of October 1, 2023,”.
