

AMENDMENT TO H.R. 5300
OFFERED BY MS. JAYAPAL OF WASHINGTON

At the appropriate place, insert the following:

1 **SEC. ____.** **LIMITATION ON FOREIGN MILITARY FINANCING**
2 **FOR ISRAEL.**

3 (a) **IN GENERAL.**—Of the amounts made available
4 under the foreign military financing program to the Gov-
5 ernment of Israel, \$1,000,000,000 shall be withheld from
6 obligation until the Secretary of State certifies to the ap-
7 propriate congressional committees whether the Govern-
8 ment of Israel is taking sustained and effective steps to
9 achieve the following:

10 (1) Refrain from annexation of the occupied
11 Palestinian territories of the West Bank and Gaza
12 Strip and end illegal settlements and their expansion
13 in the occupied Palestinian territories, including the
14 E1 corridor.

15 (2) Hold accountable individuals and entities
16 planning, ordering, otherwise directing, or partici-
17 pating in extremist settler violence, forced displace-
18 ment of people and villages, and property destruc-
19 tion in the West Bank.

1 (3) Hold Israeli security forces accountable for
2 violations, including officers credibly alleged to have
3 carried out unlawful killings, war crimes, forced dis-
4 appearances, torture, and other grave human rights
5 violations.

6 (4) Fully cooperate with United States-led in-
7 vestigations into the deaths of United States citizens
8 and take sustained and effective steps to provide
9 United States citizens with fair and commensurate
10 compensation for injuries and losses caused by the
11 Israeli military.

12 (5) Halt violations of international humani-
13 tarian and human rights law in the West Bank and
14 Gaza, including the forced displacement of Palestin-
15 ians, the restriction of humanitarian aid delivery, the
16 failure to take all necessary precautions to prevent
17 harm to civilians, and the targeting of educational,
18 religious, agricultural, and cultural sites.

19 (6) Comprehensively facilitate entry and access
20 to the Gaza Strip for journalists and humanitarian
21 aid workers.

22 (7) Implement reforms that protect freedoms of
23 expression, association, and peaceful assembly, in-
24 cluding the ability of civil society organizations,
25 human rights defenders, and the media to function

1 without interference in Israel and the occupied Pal-
2 estinian territories under Israeli military control.

3 (b) RULE OF CONSTRUCTION.—Nothing in this sec-
4 tion shall be construed to prohibit funds for the
5 \$500,000,000 in missile defense funding provided to Israel
6 on an annual basis, pursuant to the Memorandum of Un-
7 derstanding.
