To require the United States flag to be displayed on United States foreign assistance.

Mr. SHREVE introduced the following bill; which was referred to the Committee on Foreign Affairs

A BILL

To require the United States flag to be displayed on United States foreign assistance.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “American Assistance
5 Visibility Act”.

6 **SEC. 2. REQUIREMENT TO DISPLAY UNITED STATES FLAG**
7 **ON FOREIGN ASSISTANCE.**

8 The Foreign Assistance Act of 1961 (22 U.S.C. 2151
9 et seq.) is amended—

1 (1) in section 641, by striking the second sen-
2 tence; and

3 (2) by adding after such section the following:

4 **“SEC. 641A. REQUIREMENT TO DISPLAY UNITED STATES**
5 **FLAG ON FOREIGN ASSISTANCE.**

6 “(a) IN GENERAL.—The United States flag shall be
7 distinctively displayed on foreign assistance and, except as
8 provided under subsection (b), be the sole visual-branding
9 element displayed on foreign assistance.

10 “(b) EXCEPTION.—In addition to the United State
11 flag, the Secretary of State may authorize on a case-by-
12 case basis any other visual-branding element to be dis-
13 played on foreign assistance under the following:

14 “(1) When required by an international agree-
15 ment or partnership where co-branding is a formal
16 condition of such agreement or partnership.

17 “(2) When necessary for the clear identification
18 of implementing partners, provided that the United
19 States flag remains the most prominent visual-
20 branding element.

21 “(3) Any other basis the Secretary of State de-
22 termines necessary.

23 “(c) WAIVER.—The Secretary of State may waive
24 any requirement of this section as such Secretary deter-

1 mines necessary to ensure the safety or security of per-
2 sonnel or beneficiaries in high-risk locations.

3 “(d) DIRECTED RULEMAKING.—The Secretary of
4 State shall issue such regulations as are necessary to im-
5 plement this section, including specifications, with respect
6 to the United States flag, regarding—

7 “(1) minimum size requirements;

8 “(2) color accuracy;

9 “(3) placement location; and

10 “(4) any other requirement the Secretary deter-
11 mines necessary to ensure the United States flag is
12 clearly and prominently displayed on foreign assist-
13 ance.

14 “(e) FOREIGN ASSISTANCE DEFINED.—In this sec-
15 tion, the term ‘foreign assistance’ means each tangible
16 item provided by the United States Government to a for-
17 eign country or international organization under this or
18 any other Act, including—

19 “(1) buildings, equipment, vehicles, project or
20 construction site signage, and any other physical
21 asset or infrastructure;

22 “(2) food aid, medical supplies, and other com-
23 modities; and

1 “(3) banners, posters, websites, social media ac-
2 counts or posts, and other public outreach or report
3 publications.”.

4 **SEC. 3. APPLICABILITY.**

5 This Act, and the amendments made by this Act,
6 shall apply with respect to foreign assistance (as defined
7 section 641A of the Foreign Assistance Act of 1961) pro-
8 vided after the date of the enactment of this Act.
