On **Tuesday, January 11, 2022, at 10:00 a.m. ET**, the Full Committee will host a hybrid hearing on “Cybersecurity for the New Frontier: Reforming the Federal Information Security Modernization Act.” The hearing will convene in room 2154 of the Rayburn House Office Building and over Zoom, which has been approved by the House.

Members should RSVP for the hearing by Monday, January 10, 2022, to [Oversight Clerks@mail.house.gov](mailto:Oversight_Clerks@mail.house.gov) or by responding to the email that circulated this Notice. Please include in the RSVP whether you will be attending the hearing in person or via Zoom.

Per the Office of Attending Physician’s guidelines, and in consultation with the Architect of the Capitol, CAO, the Sergeant at Arms, and the Committee on House Administration, the hearing room has been reconfigured to comply with social distancing requirements. As a result, seating in the hearing room is extremely limited and may not be able to accommodate all Members at one time.

In light of current guidance from CDC and OAP, all Members, staff, and witnesses must wear properly fitted, medical-grade, filtration face masks (KN95 or N95 masks) at all times, regardless of vaccination status. Members and witnesses may remove their masks only when recognized by the Chair to speak.

Members joining remotely are asked to connect by 9:30 a.m. to ensure their participation and troubleshoot any connectivity issues. Only Members, witnesses and their counsel, and approved Committee staff are allowed into the Zoom platform. All other staff may watch via livestream on the Committee's [website](#). Members connecting through Zoom will be sent the meeting invitation link via Outlook once RSVP'd.

Attached are Zoom user guides that demonstrate how to: (1) manage various user features; and (2) ensure the best user experience by employing general best practices (e.g., optimal lighting and sound conditions). Members interested in testing Zoom before the hearing should contact Aidan Miller to arrange a test.

If any Members would like to submit documents, exhibits, or other materials into the hearing record, they may submit them through the Committee's electronic repository at Oversight_Clerks@mail.house.gov. Members are encouraged to submit such materials at least 24 hours prior to the hearing so they may be circulated to all Members prior to the hearing. Submitting such materials after this period, or during the hearing, may delay both their distribution to other Members and their approval for entering into the record.
