**MEMORANDUM**

**Re: Hearing on “The Urgent Need to Address the Gun Violence Epidemic”**

On **Wednesday, June 8, 2022, at 10:00 a.m. ET**, the Committee on Oversight and Reform will hold a hybrid hearing in **room 2154 of the Rayburn House Office Building and on the Zoom video platform** to examine the gun violence epidemic in the United States and commonsense reforms to prevent further loss of life from firearms.

**I. BACKGROUND**

On Tuesday, May 24, 2022, an 18-year-old gunman entered Robb Elementary School in Uvalde, Texas, and opened fire on children in their classrooms. He killed 19 children and two teachers.<sup>1</sup> This horrific attack followed a mass shooting just ten days earlier, when another 18-year-old gunman murdered ten innocent people—including an armed security guard—at a Tops supermarket in Buffalo, New York.<sup>2</sup> The Buffalo shooter’s attack was racially motivated and meticulously planned to target a predominately Black community.<sup>3</sup>

The mass murders in Uvalde and Buffalo are just two of the latest examples of catastrophic gun violence that are occurring more frequently and affecting more communities

nationwide. On June 1, 2022, a gunman murdered four people in a medical building in Tulsa, Oklahoma, one of more than 17 mass shootings that have occurred since the tragedy in Uvalde.<sup>4</sup>

The gun violence epidemic poses a serious public health threat to all Americans, and disproportionately impacts marginalized communities.<sup>5</sup> In 2022 alone, the United States has suffered more than 200 mass shootings.<sup>6</sup> Guns are now the leading cause of death for children and teens in the United States.<sup>7</sup> In 2020, the U.S. Centers for Disease Control and Prevention reported a total of 45,222 gun-related deaths, a nearly 15% increase over the previous year.<sup>8</sup> The U.S. leads in gun-related suicides and homicides among all high-income countries with at least 10 million inhabitants.<sup>9</sup>

The Committee has been examining gun violence in the United States for several years, and in 2019 launched an investigation into gun dealers that sell guns used in crimes.<sup>10</sup> On April 28, 2022, the Committee released preliminary findings from its investigation, showing that a small number of gun dealers—particularly those in states with lax gun laws—have sold thousands of guns used in violent crimes.<sup>11</sup>

On May 27, 2022, the Committee sent letters to five leading manufacturers of semi-automatic rifles for information related to the manufacture, marketing, and sales of their weapons, to understand how these guns are fueling the gun violence epidemic and to inform gun safety legislation to protect Americans.<sup>12</sup>
