

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 8665
OFFERED BY MRS. CAROLYN B. MALONEY OF
NEW YORK**

Strike all after the enacting clause and insert the following:

1 SEC. 1. SHORT TITLE.

2 This Act may be cited as the “National Archives and
3 Records Administration Modernization Act of 2022” or
4 the “NARA Modernization Act of 2022”.

5 SEC. 2. AMENDMENTS.

6 Title 44, United States Code, is amended—

7 (1) in section 710, by striking “his approval”
8 and inserting “approval by the President”;

9 (2) in section 711, by striking “he shall” and
10 inserting “the Director shall”;

11 (3) in section 2108—

12 (A) by striking “transferred to him” and
13 inserting “transferred to the Archivist”;

14 (B) by striking “appear to him” and in-
15 sserting “appear to the head of the Federal
16 agency”;

1 (C) by striking “his custody” and inserting
2 “the custody of the head of the Federal agen-
3 cy”;

4 (D) by striking “he concurs,” and insert-
5 ing “the Archivist concurs”;

6 (E) by striking “his successor in function”,
7 each place it appears, and inserting “the suc-
8 cessor in function of the head of the agency”;
9 and

10 (F) by striking “he determines” and in-
11 sserting “the Archivist determines”;

12 (4) in section 2109—

13 (A) by striking “to him” and inserting “to
14 the Archivist”; and

15 (B) by striking “He may” and inserting
16 “The Archivist may”;

17 (5) in section 2110—

18 (A) by striking “he considers” and insert-
19 ing “the Archivist considers”; and

20 (B) by striking “his custody” and inserting
21 “the custody of the Archivist”;

22 (6) in section 2112—

23 (A) by striking “he may”, each place it ap-
24 pears, and inserting “the Archivist may”;

1 (B) by striking “in him” and inserting “in
2 the Archivist”;

3 (C) by striking “his custody” and inserting
4 “the custody of the Archivist”; and

5 (D) by striking “his control” and inserting
6 “the control of the Archivist”;

7 (7) in section 2307, by striking “his designee”
8 and inserting “the designee of the Archivist”;

9 (8) in section 2903, by striking “by him” and
10 inserting “by the Archivist”;

11 (9) in section 3308, by striking “he may” and
12 inserting “the Archivist may”;

13 (10) in section 3310, by striking “he considers”
14 and inserting “the Archivist considers”; and

15 (11) in section 3311—

16 (A) by striking “his legal custody” and in-
17 serting “the legal custody of the head of the
18 agency of the United States Government”;

19 (B) by striking “his opinion” and inserting
20 “the opinion of such head of such agency”;

21 (C) by striking “he shall” and inserting
22 “such official shall”; and

23 (D) by striking “he disposed” and insert-
24 ing “such official disposed”.
