RESOLUTION

Of inquiry requesting the President to transmit certain documents relating to the use of insecure electronic communication platforms, including Signal, for official communications and to the compliance of the Administration with all Federal records laws.

- 1 *Resolved*, That the President is requested to transmit,
- 2 to the extent that such documents are in the possession
- 3 of the President, to the House of Representatives, not
- 4 later than 14 days after the adoption of this resolution,
- 5 in a complete and unredacted form, a copy of any docu-

1 ment, record, report, memorandum, correspondence, or
2 other communication that refers or relates to the fol-
3 lowing:

4 (1) The plan of the Administration to preserve
5 in compliance with Federal recordkeeping require-
6 ments all official communications, including any offi-
7 cial communications—

8 (A) containing highly sensitive national se-
9 curity information; and

10 (B) sent via electronic communication plat-
11 forms (such as Signal, SMS, iMessage,
12 WhatsApp, Teams, MatterMost, Slack, and
13 Gmail).

14 (2) The conduct of official business via elec-
15 tronic communication platforms on Federal Govern-
16 ment devices, including—

17 (A) via platforms such as Signal, SMS,
18 iMessage, WhatsApp, Teams, MatterMost,
19 Slack, and Gmail; and

20 (B) such official business that involves the
21 communication of highly sensitive national secu-
22 rity information.

23 (3) The conduct of official business via elec-
24 tronic communication platforms on personal devices
25 in violation of Federal law, including—

1 (A) via platforms such as Signal, SMS,
2 iMessage, WhatsApp, Teams, MatterMost,
3 Slack, and Gmail; and

4 (B) such official business that involves the
5 communication of highly sensitive national secu-
6 rity information.

7 (4) Plans, procedures, guidance, or practices to
8 ensure that communications involving official busi-
9 ness are not set to automatically delete after a pe-
10 riod of time in violation of Federal recordkeeping re-
11 quirements when such communications are sent via
12 electronic communication platforms, including any
13 such communications—

14 (A) containing highly sensitive national se-
15 curity information; and

16 (B) sent via such platforms as Signal,
17 SMS, iMessage, WhatsApp, Teams,
18 MatterMost, Slack, and Gmail.
