  - a. Which companies have compensated you to advertise or promote such products?
  - b. How much have each of those companies compensated you to advertise or promote such products?
  - c. List the date(s) you received payment(s) from each such company for advertising or promoting such products.
2. Have you ever given away products provided by an e-cigarette or vape company to listeners of your radio show or followers of your social media accounts or who contacted you through another channel?
  - a. Which companies have provided products for you to give away?
  - b. List the date(s) of all such activities.
  - c. What compensation did you receive for each such activity?
3. Have you ever appeared in an advertisement or promotion for e-cigarettes, vapes, or any related products?
  - a. For what products have you appeared in such advertisements or promotions?
  - b. How much were you compensated for your appearances in these advertisements or promotions?
  - c. On what dates were you compensated for such advertisements or promotions?
4. Do you have, or have you ever had, an economic interest, ownership stake, or other financial relationship with any e-cigarette manufacturer, retailer, or other business related to e-cigarettes, vapes, e-liquids, or tobacco? Have you ever

received compensation, payment, honoraria, speaking or appearance fee, travel reimbursement, or any other remuneration from any entity related to the e-cigarette industry or funded (in whole or in part) by the e-cigarette industry?
