Biographical Information

Shelley R. Slade is a partner in Vogel, Slade & Goldstein, LLP, a Washington, D.C., law firm with a nationwide practice representing *qui tam* plaintiffs under the federal False Claims Act. In 2007, 2009 and 2011, in its biannual review of attorneys, the Washingtonian Magazine honored Ms. Slade as one of the best Whistleblower Attorneys, selecting her as one of the top 1% of attorneys in all practices in the metropolitan D.C. area.

Ms. Slade serves on the Board of Directors and on the executive committee of Taxpayers Against Fraud (TAF) and its affiliate, the TAF Education Fund, nonprofit, public interest organizations dedicated to combating fraud against the government and protecting public resources through public-private partnerships.

Ms. Slade has testified before the Committee on the Judiciary of the U.S. House of Representatives, the National Association of Attorney Generals and the New York City Council concerning the False Claims Act. She speaks regularly at key legal conferences on the False Claims Act and has published a number of articles in the area.

Prior to entering private practice in 2000, Ms. Slade was the Senior Counsel for Health Care Fraud for the Civil Division of the U.S. Department of Justice. In that position, she coordinated the Civil Division's health care fraud enforcement efforts with other government agencies and the private sector, handled related policy and legislative matters, and instructed Department of Justice attorneys and investigators on the investigation and prosecution of false claims act matters.

Between 1990 and 1997, Ms. Slade investigated and litigated fraud matters in the Civil Fraud Section of the Commercial Litigation Branch - - the office of the Department of Justice that handles the most significant and large-scale False Claims Act cases in the country. As a trial attorney in the Commercial Litigation Branch, Ms. Slade primarily handled matters involving fraud on the U.S. Department of Defense, and fraud involving state and foreign governmental entities.

Between 1984 and 1989, Ms. Slade handled international trade and litigation matters at the Washington, D.C., law firm Arnold & Porter. While at Arnold & Porter, she was named Pro Bono Lawyer of the Year by the D.C. Bar Association. She left the firm in 1989 to help start up Shearman & Sterling's Washington, D.C. office with two former Arnold & Porter international trade partners. She practiced at Shearman & Sterling in 1989 and 1990.
