**Bio:** Jennifer Schulp is the director of financial regulation studies at the Cato Institute’s Center for Monetary and Financial Alternatives. She focuses on the regulation of securities and capital markets and has testified before the House Committee on Financial Services. Prior to joining Cato, Jennifer was a director in the Department of Enforcement at the Financial Industry Regulatory Authority Inc. (FINRA) where she represented FINRA in investigations and disciplinary proceedings relating to violations of the federal securities laws and self-regulatory organization rules. Before joining FINRA, Jennifer was a litigation

associate at Gibson, Dunn & Crutcher LLP where she represented corporate and individual clients regarding claims under a variety of federal and state laws, including class actions, ERISA stock drop cases, Rule 10b-5 actions, Sarbanes-Oxley whistleblower provisions, and Title VII of the Civil Rights Act of 1964. She clerked for the Honorable E. Grady Jolly of the U.S. Court of Appeals for the Fifth Circuit, and she received her J.D. from the University of Chicago Law School and her A.B. in political science from the University of Chicago.
