

AMENDMENT TO H.R. 4284

OFFERED BY MR. LATTA OF OHIO

**[Amending the text of H.R. 4284 as forwarded by the
Subcommittee on Health on April 25, 2018]**

Page 2, strike line 1 and all that follows through
page 3, line 9, and insert the following:

1 **SEC. 2. ESTABLISHMENT OF SUBSTANCE USE DISORDER IN-**
2 **FORMATION DASHBOARD.**

3 Title XVII of the Public Health Service Act (42
4 U.S.C. 300u et seq.) is amended by adding at the end
5 the following new section:

6 **“SEC. 1711. ESTABLISHMENT OF SUBSTANCE USE DIS-**
7 **ORDER INFORMATION DASHBOARD.**

8 “(a) IN GENERAL.—Not later than six months after
9 the date of the enactment of this section, the Secretary
10 of Health and Human Services shall, in consultation with
11 the Director of National Drug Control Policy, establish
12 and periodically update a public information dashboard
13 that—

14 “(1) coordinates information on programs with-
15 in the Department of Health and Human Services
16 related to the reduction of opioid abuse and other
17 substance use disorders;

1 “(2) provides access to publicly available data
2 from other Federal agencies; State, local, and Tribal
3 governments; nonprofit organizations; law enforce-
4 ment; medical experts; public health educators; and
5 research institutions regarding prevention, treat-
6 ment, recovery, and other services for opioid use dis-
7 order and other substance use disorders;

8 “(3) provides comparable data on substance use
9 disorder prevention and treatment strategies in dif-
10 ferent regions and population of the United States;

11 “(4) provides recommendations for health care
12 providers on alternatives to controlled substances for
13 pain management, including approaches studied by
14 the National Institutes of Health Pain Consortium
15 and the National Center for Complimentary and In-
16 tegrative Health; and

17 “(5) provides guidelines and best practices for
18 health care providers regarding treatment of sub-
19 stance use disorders.

20 “(b) CONTROLLED SUBSTANCE DEFINED.—In this
21 section, the term ‘controlled substance’ has the meaning
22 given that term in section 102 of the Controlled Sub-
23 stances Act (21 U.S.C. 802).”.

Page 3, beginning on line 23, strike “The Com-
mittee shall be composed of” and all that follows through

“designees of such members):” and insert the following:
“The following individuals shall be the Federal members
of the Committee.”

Page 5, line 2, strike “be composed of” and insert
“include”.

Page 7, line 24, strike “evaluate the effectiveness
of” and insert “identify and provide to the Secretary rec-
ommendations for improving”.
