### Budget Reconciliation Legislative Recommendations Relating to Drinking Water

---

#### 1           **Subtitle C—Drinking Water**

##### 2   **SEC. 30301. LEAD SERVICE LINE REPLACEMENT.**

3           (a) IN GENERAL.—In addition to amounts otherwise  
4 available, there is appropriated for fiscal year 2022, out  
5 of any money in the Treasury not otherwise appropriated,  
6 \$30,000,000,000, to make capitalization grants under sec-  
7 tion 1452 of the Safe Drinking Water Act (42 U.S.C.  
8 300j–12), to remain available until expended, for full lead  
9 service line replacement projects and associated activities  
10 directly connected to the identification, planning, design,  
11 and full replacement of lead service lines, of which  
12 \$20,000,000,000 shall be for subsidies to disadvantaged  
13 communities (as defined in subsection (d)(3) of such sec-  
14 tion) in the form of loans, with 100 percent forgiveness  
15 of principal, or grants, notwithstanding subsection (d)(2)  
16 of such section.

17           (b) PROHIBITION ON PARTIAL LINE REPLACEMENT.—No funds made available under this section may  
18 be used for partial replacement of lead service lines.

1 (c) NO LEVERAGING.—Funds made available under  
2 this section may not be used as a source of payment of,  
3 or security for (directly or indirectly), in whole or in part,  
4 any obligation the interest on which is exempt from the  
5 tax imposed under chapter 1 of the Internal Revenue Code  
6 of 1986.

7 **SEC. 30302. COMMUNITY WATER SYSTEM RISK AND RESIL-**  
8 **IENCE.**

9 In addition to amounts otherwise available, there is  
10 appropriated for fiscal year 2022, out of any money in  
11 the Treasury not otherwise appropriated, \$500,000,000,  
12 to remain available until expended, for grants under sec-  
13 tion 1433(g) of the Safe Drinking Water Act (42 U.S.C.  
14 300i–2(g)).

15 **SEC. 30303. GRANTS FOR STATE PROGRAMS.**

16 In addition to amounts otherwise available, there is  
17 appropriated for fiscal year 2022, out of any money in  
18 the Treasury not otherwise appropriated, \$100,000,000,  
19 to remain available until expended, for grants under sec-  
20 tion 1443 of the Safe Drinking Water Act (42 U.S.C.  
21 300j–2).

22 **SEC. 30304. ASSISTANCE FOR COLONIAS.**

23 In addition to amounts otherwise available, there is  
24 appropriated for fiscal year 2022, out of any money in  
25 the Treasury not otherwise appropriated, \$100,000,000,

1 to remain available until expended, for grants under sec-  
2 tion 1456 of the Safe Drinking Water Act (42 U.S.C.  
3 300j-16).

4 **SEC. 30305. GRANTS TO REDUCE LEAD IN SCHOOL DRINK-**  
5 **ING WATER.**

6 In addition to amounts otherwise available, there is  
7 appropriated for fiscal year 2022, out of any money in  
8 the Treasury not otherwise appropriated, \$700,000,000,  
9 to remain available until expended, for grants under sec-  
10 tions 1464 and 1465 of the Safe Drinking Water Act (42  
11 U.S.C. 300j-24 and 300j-25), of which—

12 (1) \$500,000,000 shall be for grants for the in-  
13 stallation and maintenance of lead filtration stations  
14 at schools and child care programs;

15 (2) \$150,000,000 shall be for grants under sec-  
16 tion 1464(d); and

17 (3) \$50,000,000 shall be for grants under sec-  
18 tion 1465(b)(1) to pay the costs of replacement of  
19 drinking water fountains in schools.

20 **SEC. 30306. GRANTS FOR INDIAN RESERVATION DRINKING**  
21 **WATER INFRASTRUCTURE.**

22 In addition to amounts otherwise available, there is  
23 appropriated for fiscal year 2022, out of any money in  
24 the Treasury not otherwise appropriated, \$100,000,000,  
25 to remain available until expended, to implement eligible

1 projects under section 2001 of America's Water Infra-  
2 structure Act of 2018 (42 U.S.C. 300j-3c note), notwith-  
3 standing the geographic limitations in that section.

4 **SEC. 30307. ASSISTANCE FOR AREAS AFFECTED BY NAT-**  
5 **URAL DISASTERS.**

6 In addition to amounts otherwise available, there is  
7 appropriated for fiscal year 2022, out of any money in  
8 the Treasury not otherwise appropriated, \$100,000,000,  
9 to remain available until expended, for grants under sec-  
10 tion 2020 of America's Water Infrastructure Act of 2018  
11 (42 U.S.C. 300j-12 note), of which, notwithstanding sub-  
12 section (a)(2) of such section, \$10,000,000 shall be avail-  
13 able to make grants to Guam, the Virgin Islands, Amer-  
14 ican Samoa, and the Northern Mariana Islands for the  
15 purposes of providing assistance to eligible systems to re-  
16 store or increase compliance with national primary drink-  
17 ing water regulations in an underserved area.

18 **SEC. 30308. ASSISTANCE FOR DISADVANTAGED COMMU-**  
19 **NITIES.**

20 In addition to amounts otherwise available, there is  
21 appropriated for fiscal year 2022, out of any money in  
22 the Treasury not otherwise appropriated, \$200,000,000,  
23 to remain available until expended, for grants under sec-  
24 tion 1459A(b) of the Safe Drinking Water Act (42 U.S.C.  
25 300j-19a(b)).

1 **SEC. 30309. GRANTS FOR CONTAMINANT MONITORING.**

2 In addition to amounts otherwise available, there is  
3 appropriated for fiscal year 2022, out of any money in  
4 the Treasury not otherwise appropriated, \$100,000,000,  
5 to remain available until expended, to make grants to pay  
6 for the costs of monitoring required under section  
7 1445(a)(2) of the Safe Drinking Water Act (42 U.S.C.  
8 300j-4(a)(2)).

9 **SEC. 30310. TECHNICAL ASSISTANCE TO SMALL PUBLIC**  
10 **WATER SYSTEMS.**

11 In addition to amounts otherwise available, there is  
12 appropriated for fiscal year 2022, out of any money in  
13 the Treasury not otherwise appropriated, \$100,000,000,  
14 to remain available until expended, to provide technical as-  
15 sistance under section 1442(e) of the Safe Drinking Water  
16 Act (42 U.S.C. 300j-1(e)).

17 **SEC. 30311. FUNDING FOR WATER ASSISTANCE PROGRAM.**

18 (a) IN GENERAL.—In addition to amounts otherwise  
19 available, there is appropriated to the Secretary of Health  
20 and Human Services (in this section referred to as the  
21 “Secretary”) for fiscal year 2022, out of any money in  
22 the Treasury not otherwise appropriated, \$500,000,000,  
23 to remain available until expended, for grants to States  
24 and Indian Tribes to assist low-income households, par-  
25 ticularly those with the lowest incomes, that pay a high  
26 proportion of household income for drinking water and

1 wastewater services, by providing funds to owners or oper-  
2 ators of public water systems or treatment works to reduce  
3 arrearages of and rates charged to such households for  
4 such services.

5 (b) ALLOTMENT.—The Secretary shall—

6 (1) allot amounts appropriated in this section to  
7 a State or Indian Tribe based on—

8 (A) the percentage of households in the  
9 State, or under the jurisdiction of the Indian  
10 Tribe, with income equal to or less than 150  
11 percent of the Federal poverty line; and

12 (B) the percentage of households in the  
13 State, or under the jurisdiction of the Indian  
14 Tribe, that spend more than 30 percent of  
15 monthly income on housing; and

16 (2) reserve up to 3 percent of the amount ap-  
17 propriated in this section for Indian Tribes and  
18 Tribal organizations.

19 (c) DEFINITION.—In this section, the term “State”  
20 means each of the 50 States of the United States, the  
21 District of Columbia, the Commonwealth of Puerto Rico,  
22 American Samoa, Guam, the Virgin Islands, and the Com-  
23 monwealth of the Northern Mariana Islands.
