Mr. RUSH (for himself and Mr. MULLIN) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To amend title VII of the Public Health Service Act to authorize assistance for increasing workforce diversity in the professions of physical therapy, occupational therapy, respiratory therapy, audiology, and speech-language pathology, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Allied Health Work-
5 force Diversity Act of 2021”.

1 **SEC. 2. INCREASING WORKFORCE DIVERSITY IN THE PRO-**
2 **FESSIONS OF PHYSICAL THERAPY, OCCUPA-**
3 **TIONAL THERAPY, RESPIRATORY THERAPY,**
4 **AUDIOLOGY, AND SPEECH-LANGUAGE PA-**
5 **THOLOGY.**

6 Title VII of the Public Health Service Act is amend-
7 ed—

8 (1) by redesignating part G (42 U.S.C. 295h)
9 as part H; and

10 (2) by inserting after part F (42 U.S.C. 294n
11 et seq.) the following new part:

12 **“PART G—INCREASING WORKFORCE DIVERSITY**
13 **IN THE PROFESSIONS OF PHYSICAL THER-**
14 **APY, OCCUPATIONAL THERAPY, RES-**
15 **PIRATORY THERAPY, AUDIOLOGY, AND**
16 **SPEECH-LANGUAGE PATHOLOGY**

17 **“SEC. 783. SCHOLARSHIPS AND STIPENDS.**

18 “(a) IN GENERAL.—The Secretary may award grants
19 and contracts to eligible entities to increase educational
20 opportunities in the professions of physical therapy, occu-
21 pational therapy, respiratory therapy, audiology, and
22 speech-language pathology for eligible individuals by—

23 “(1) providing student scholarships or stipends,
24 including for—

25 “(A) completion of an accelerated degree
26 program;

1 “(B) completion of an associate’s, bach-
2 elor’s, master’s, or doctoral degree program;
3 and

4 “(C) entry by a diploma or associate’s de-
5 gree practitioner into a bridge or degree com-
6 pletion program;

7 “(2) providing assistance for completion of pre-
8 requisite courses or other preparation necessary for
9 acceptance for enrollment in the eligible entity; and

10 “(3) carrying out activities to increase the re-
11 tention of students in one or more programs in the
12 professions of physical therapy, occupational ther-
13 apy, respiratory therapy, audiology, and speech-lan-
14 guage pathology.

15 “(b) CONSIDERATION OF RECOMMENDATIONS.—In
16 carrying out subsection (a), the Secretary shall take into
17 consideration the recommendations of national organiza-
18 tions representing the professions of physical therapy, oc-
19 cupational therapy, respiratory therapy, audiology, and
20 speech-language pathology, including the American Phys-
21 ical Therapy Association, the American Occupational
22 Therapy Association, the American Speech-Language-
23 Hearing Association, the American Association for Res-
24 piratory Care, the American Academy of Audiology, and
25 the Academy of Doctors of Audiology.

1 “(c) REQUIRED INFORMATION AND CONDITIONS FOR
2 AWARD RECIPIENTS.—

3 “(1) IN GENERAL.—The Secretary may require
4 recipients of awards under this section to report to
5 the Secretary concerning the annual admission, re-
6 tention, and graduation rates for eligible individuals
7 in programs of the recipient leading to a degree in
8 any of the professions of physical therapy, occupa-
9 tional therapy, respiratory therapy, audiology, and
10 speech-language pathology.

11 “(2) FALLING RATES.—If any of the rates re-
12 ported by a recipient under paragraph (1) fall below
13 the average for such recipient over the two years
14 preceding the year covered by the report, the recipi-
15 ent shall provide the Secretary with plans for imme-
16 diately improving such rates.

17 “(3) INELIGIBILITY.—A recipient described in
18 paragraph (2) shall be ineligible for continued fund-
19 ing under this section if the plan of the recipient
20 fails to improve the rates within the 1-year period
21 beginning on the date such plan is implemented.

22 “(d) DEFINITIONS.—In this section:

23 “(1) ELIGIBLE ENTITIES.—The term ‘eligible
24 entity’ means an accredited education program that
25 is carrying out a program for recruiting and retain-

1 ing students underrepresented in the professions of
2 physical therapy, occupational therapy, respiratory
3 therapy, audiology, and speech-language pathology
4 (including racial or ethnic minorities, or students
5 from disadvantaged backgrounds).

6 “(2) ELIGIBLE INDIVIDUAL.—The term ‘eligible
7 individual’ means an individual who—

8 “(A) is a member of a class of persons who
9 are underrepresented in the professions of phys-
10 ical therapy, occupational therapy, respiratory
11 therapy, audiology, and speech-language pathol-
12 ogy, including individuals who are—

13 “(i) racial or ethnic minorities;

14 “(ii) from disadvantaged backgrounds;

15 or

16 “(iii) individuals with a disability (as
17 defined in section 3(1) of the Americans
18 with Disabilities Act of 1990), or who have
19 an individualized education program (as
20 defined in section 602 of the Individuals
21 with Disabilities Education Act), are cov-
22 ered under section 504 of the Rehabilita-
23 tion Act of 1973, or have other documenta-
24 tion establishing the student’s disability
25 (as such term is defined in section 3(1) of

1 the Americans with Disabilities Act of
2 1990);

3 “(B) has a financial need for a scholarship
4 or stipend; and

5 “(C) is enrolled (or accepted for enroll-
6 ment) at an audiology, speech-language pathol-
7 ogy, respiratory therapy, physical therapy, or
8 occupational therapy program as a full-time
9 student at an eligible entity.

10 “(e) AUTHORIZATION OF APPROPRIATIONS.—There
11 is authorized to be appropriated to carry out this section
12 \$8,000,000 for the first fiscal year commencing after the
13 date of enactment of the Allied Health Workforce Diver-
14 sity Act of 2021 and each of the 4 succeeding fiscal
15 years.”.

16 **SEC. 3. ELIGIBILITY CLARIFICATION REGARDING STU-**
17 **DENTS SUPPORTED THROUGH MENTAL AND**
18 **BEHAVIORAL HEALTH EDUCATION AND**
19 **TRAINING GRANTS.**

20 Section 756(a)(1) of the Public Health Service Act
21 (42 U.S.C. 294e–1(a)(1)) is amended after “occupational
22 therapy” by inserting “(which may include master’s and
23 doctoral level programs)”.
