

Alice M. Rivlin is a senior fellow in the Economic Studies Program at the Brookings Institution, and serves as co-chair of the Long-term Care Initiative at the Bipartisan Policy Center. She is also a visiting professor at the McCourt School of Public Policy at Georgetown University. She was formerly the Director of the Health Policy Center (2013-15).

Ms. Rivlin served as vice chair of the Federal Reserve Board (1996-99). She was deputy director and then director of the White House Office of Management and Budget in the first Clinton administration (1993-96). She also chaired the District of Columbia Financial Management Assistance Authority (1998-2001). Ms. Rivlin was the founding director of the Congressional Budget Office (1975-83). She was director of the Economic Studies Program at Brookings (1983-87). She also served at the Department of Health, Education and Welfare as Assistant Secretary for Planning and Evaluation.

In 2010, Ms. Rivlin was named by President Obama to the Commission on Fiscal Responsibility and Reform and also co-chaired, with former Senator Pete Domenici, the Bipartisan Policy Center's Task Force on Debt Reduction.

Ms. Rivlin served as vice chair of the Federal Reserve Board (1996-99). She was deputy director and then director of the White House Office of Management and Budget in the first Clinton administration (1993-96). She also chaired the District of Columbia Financial Management Assistance Authority (1998-2001). Ms. Rivlin was the founding director of the Congressional Budget Office (1975-83). She was director of the Economic Studies Program at Brookings (1983-87). She also served at the Department of Health, Education and Welfare as Assistant Secretary for Planning and Evaluation.

Ms. Rivlin received the Paul A. Volcker Lifetime Achievement Award for Economic Policy from the National Association of Business Economics (2015) and the President's Medal from Indiana University). In 2015 she also received the Leadership Award from the Economic Club of New York. She has received a MacArthur Foundation Prize Fellowship in 1983 and the Moynihan Prize in 2008. She was named one of the greatest public servants of the last 25 years by the Council for Excellence in Government in 2008. In 2013 she is received Robert M. Ball Award for Outstanding Achievements in Social Insurance from the National Academy of Social Insurance. She has taught at Harvard, George Mason, and The New School Universities. She has served on the boards of directors of several corporations, and as president of the American Economic Association.

Ms. Rivlin is a frequent contributor to newspapers, television, and radio. Her books include *Systematic Thinking for Social Action* (1971), *Reviving the American Dream* (1992), and *Beyond the Dot.coms* (with Robert Litan, 2001). She is co-editor (with Isabel Sawhill) of *Restoring Fiscal Sanity: How to Balance the Budget* (2004), *Restoring Fiscal Sanity 2005: Meeting the Long-Run Challenges*, (with Joseph Antos) of *Restoring Fiscal Sanity 2007: The Health Spending Challenge*, and (with Litan) of *The Economic Payoff from the Internet Revolution* (2001).

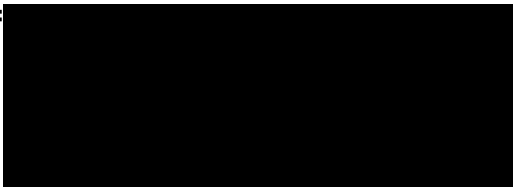
