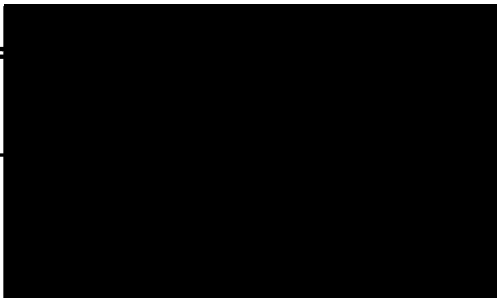
Scott Gottlieb, MD is a practicing physician and Resident Fellow at the American Enterprise Institute. Dr. Gottlieb's work focuses on providing insights into the economic and technological forces driving the transformation of healthcare. From 2005-2007, Dr. Gottlieb served as FDA Deputy Commissioner for Medical and Scientific Affairs and before that, from 2003-2004, as a senior advisor to the FDA Commissioner and as the FDA's Director of Medical Policy Development. He left FDA in the spring of 2004 to work on implementation of the new Medicare Drug Benefit as a Senior Adviser to the Administrator of the Centers for Medicare and Medicaid Services, where he supported policy work on quality improvement and the agency's coverage process, particularly related to new medical technologies. In 2013 he was appointed by the Senate Majority Leader to serve on the Federal Health Information Technology Policy Committee, which advises the Department of Health and Human Services on healthcare information technology.

Dr. Gottlieb is a contributor to the editorial page of the Wall Street Journal and has held editorial positions on the British Medical Journal and the Journal of the American Medical Association. His work also appears in USA Today, The New York Times, and the Los Angeles Times, and he is a guest commentator on the cable financial cable news channel CNBC and on Fox News Channel. Dr. Gottlieb is editorial board member of the journal Value Based Cancer Care, the Food and Drug Law Institute's Policy Forum, and is a member of the board of advisers of Cancer Commons. He serves as an advisor to the National Comprehensive Cancer Network, and the National Coalition for Cancer Survivorship and as a member of the policy boards to the Leukemia and Lymphoma Society and the Society of Hospitalist Medicine. Dr. Gottlieb previously served as a Healthcare Adviser to the 2012 Presidential Campaign of Mitt Romney and as a Senior Adviser to the 2016 Presidential campaign of Governor Scott Walker. Dr. Gottlieb serves as an advisor to healthcare investors and as a board member to life science and healthcare services companies. He is a Clinical Assistant Professor at the New York University School of Medicine in Manhattan. He completed a residency in internal medicine at the Mount Sinai Hospital in New York and is a graduate of the Mount Sinai School of Medicine in New York and of Wesleyan University, in Middletown, Connecticut, where he studied Economics.
